February 22, 2016

The Agenda Meeting of the Town Board of the Town of Charlton, Saratoga County, New York was held at the Charlton Town Hall, 758 Charlton Rd, Charlton, NY and called to order by Supervisor Grattidge at 7:31 p.m. to set the agenda for the March 14th Meeting.

DISCUSSION

The Sales Tax report for the month has not yet been received. The Mortgage Tax was \$16,558.00. Supervisor Grattidge confirmed that the Board has received a letter from Saratoga County listing the total of monies disbursed to the Town for 2015 for Sales Tax, Mortgage Tax and Shelter fees.

Supervisor Grattidge reported that the January Dog Control report has been received, and there were 7 dog calls responded to in January.

Supervisor Grattidge confirmed that one bid was received for the Ford F550 pick-up truck, and the Highway Superintendent has reviewed the bid.

The Highway Superintendent had given the Board quotes for a new dump body for the new Ford 550 pick-up truck that he would like to purchase. Mike Emerich verified that the dump body comes primed, and will need to be painted. He also confirmed that the plow equipment will be used from the old truck, and that he will be installing a tank to the new truck for the salt brine.

The Board discussed the Spring newsletter and decided that the article submission deadline should be March 18th with hopes of getting the newsletter in homes in the beginning of April. Brush pick-up was discussed and Mike Emerich decided to do the pick-up during the week of April 18th to April 22nd. Supervisor Grattidge said that he will contact County Waste about bulk item pick-up and see if they can schedule the pick-up for the week of May 9 to May 13th. Supervisor Grattidge asked the Town Clerk to check on the mailing list for the newsletter and about adding current resident to the address line.

Supervisor Grattidge said that Charlton and the Town of Ballston have agreed to have their Building Inspectors be back-up for each other to cover time off. If either Town incurs expenses such as mileage, they will bill each other by voucher. Attorney Van Vranken will work on a written Shared Service Agreement.

Supervisor Grattidge reported that during a State inspection of the furnace, a slight leak was found in an exhaust pipe. The HVAC contractor found a leak in a glue joint that was in a chase in a restroom. It appears that when the pipe was originally installed, it was not completely glued. The pipe was re-glued and is no longer leaking. The State also asked that braces be built as under-supports for the exhaust pipes in the basement. Don Smith is working on this project. The HVAC contractor also tested the glycol in the system, and it tested at 33%, which is the same as the specs for the system. Since bleeder valves were changed on the air handlers in the attic, the system has not lost any fluid. Supervisor Grattidge said that he would suggest that the Board hold off on putting in the glycol injector system which costs around \$6,000.00. He said that the Town would have to regularly check the glycol levels. Supervisor Grattidge said that the intake valve for fresh water is in the off position, so if a coil breaks again it would be a minimum amount of water loss. The Supervisor said that he checked the temperature of the attic space on a 10 degree day and the temperature was 45-50 degrees, so he feels that the insulation that was installed is working.

Supervisor Grattidge said that the 2015 AUD (Annual Audit Report) has been completed and submitted to the State, and will be posted to the website. The report includes a breakdown of the Fund Balance, and will be useful in preparing next year's budget.

Supervisor Grattidge said that in January, the Board amended the Organizational Resolution to add a 6th member to the Historic District Commission. Since the amendment, that Board has found that a 1973 Local Law says that the Commission may only consist of 5 members. Attorney Van Vranken will create a new resolution to re-amend the Organizational Resolution.

The Supervisor said that Marv Schorr will take photos of the Town Board for the website at the March 14th meeting.

Supervisor Grattidge attended the Association of Towns annual meeting where he took some training classes from Dr. Orr from Cornell regarding highway/roadways. He said that the handouts were useful and interesting, so he will make copies for the Board and Highway Superintendent.

Supervisor Grattidge said that the Board will go into Executive Session after tonight's meeting to discuss a personnel issue.

Cab 141" WB, Cab and Chassis.

NOW BE IT RESOLVED, that the Town Board awards the contract for the 2016 Ford Super Duty F-550 DRW 4WD Reg. Cab 141" WB, Cab and Chassis to Morris Ford, Inc., according to the recommendation of the Town Highway Superintendent for the price of \$47,913.00 and hereby directs the Supervisor and the Town Highway Superintendent to take whatever steps are necessary to execute an agreement between the Town of Charlton and Morris Ford, Inc. for the purchase of said vehicle.

BE IT FURTHER RESOLVED, that notice is hereby given that any person or persons violating this order shall be subject to enforcement as provided in §1800 of the New York State Vehicle and Traffic Law.
