## **ANNOUNCEMENTS**

Brush Pick-Up will begin the week of April 17<sup>th</sup>. Brush should be put curbside with limb ends facing the road. One pass through will be made through Town so all brush should be put out by the 17<sup>th</sup>. This pick-up is intended for removal of yard trimmings and storm related brush, and is not intended for tree removal. The Town will not be picking up trees that have been cut down.

Bulk Item Pick-up will be the week of May 23<sup>rd</sup>. County Waste has informed the Supervisor that they are limiting the amount of waste that they will collect from each home. The pile is not to exceed 4x8x4 feet. They will be sending inspectors out, and if there is excess waste, they will inform the homeowner of the cost of removing the excess if they chose to have them take it. There will not be a dumpster at the Highway Garage for metal this year. Metal will be picked up by County Waste. Information is on the Town's website.

A public presentation by Saratoga Plan and Saratoga County Planning Board will be held at the Charlton Town Hall on March 31<sup>st</sup> at 6:30 p.m. to present "Farmland Conservation Options for Landowners".

#### **DISCUSSION**

The Sales Tax report for the month was \$87,132.00 and the Mortgage Tax was \$6,523.00. Supervisor Grattidge noted that both amounts are lower than at this time last year.

Supervisor Grattidge that a study was done and Saratoga County was rated the healthiest county in New York State.

The Board had received a request from the BHBL Girls Modified La Crosse team to be able to do a community service project in Charlton. In the past they have done roadside clean-up. The Board suggested that they clean the Veterans Memorial Board and do some ground clean-up in Gideon Hawley Park.

The Town Board did a walk-through at the Community Center and noted some items to be taken care of. They approved a request by the Seniors to have grab bars installed in the restrooms. Councilman Grasso also noted that the attic could use some cleaning. Supervisor Grattidge will ask the Town's Maintenance worker to take care of these items. Councilman Hodgkins noted that a few fascia boards on the building need replacing and a few tree branches close to the building need to be taken down. He will talk to the Highway Superintendent about getting these things taken care of.

Supervisor Grattidge said that he spoke with a representative from United Health Insurance and they have a health insurance plan for retirees that costs \$69 per month which is considerably less than the \$280 per month for the current plan that the Town carries. The major difference in the coverage is the hospitalization coverage which the current plan has no co-pay for, and the United plan has a co-pay of \$295 per day for the first 4 days. Supervisor Grattidge pointed out that the plan for current employees have has a \$1,000 deductible for hospitalization. Councilman Grasso said that he felt that this is something that the Board should strongly consider. No action was taken tonight.

Councilman Grasso said that he talked to the Town Clerk about a possible dog enumeration. The Clerk said that there are two different ways to do an enumeration. One option is to send Dog Control door to door, which would require a lot of man hours. The other option is to send a returnable post card asking every homeowner to verify whether or not they have dogs. The Dog Control officer would follow up on households that do not return the card. The Board will consider the options, and asked the Clerk to put mention of a possible enumeration in the newsletter.

The Clerk verified that the proof of the Spring newsletter has been sent to the printer, and is on schedule to go in the mail the first week in April.

The Town Board has seen a proof for the new banner for Founder's Day. The cost of the banner is \$150.00, and Supervisor Grattidge suggested that the Town pay for it.

Supervisor Grattidge asked the Town Attorney to prepare a resolution for the next meeting, regarding the Board accepting the Town Department audits.

# A RESOLUTION AUTHORIZING THE EXPENDITURES FOR REPAIR AND IMPROVEMENT OF TOWN HIGHWAYS AUTHORIZED BY SECTION 284 OF THE NEW YORK STATE HIGHWAY LAW

WHEREAS, New York State Highway Law Section 284 requires that expenditures for the repair and improvement of Town highways requires that an agreement between the Town Board and the Town Superintendent of Highways be signed, and

WHEREAS, such agreement between the Board and Superintendent shall be in writing, signed in duplicate by a majority of the members of the Town Board and by the Town Superintendent of Highways before the agreement shall take effect, and

WHEREAS, one of the duplicate agreements between the Town Board and Superintendent of Highways shall be filed in the Office of Town Clerk and one duplicate original agreement shall be filed in the Office of the Superintendent of Highways.

NOW THEREFORE BE IT RESOLVED, that the Town Board and Superintendent of Highways shall execute an agreement for the expenditure of highway monies pursuant to Section 284 of the Highway Law, which agreement is attached to this resolution and made a part hereof as if more fully set forth herein, setting forth the expenditures to be set aside in the sum of \$108,664.00 and describing the Town highways on which repair and improvements shall be made during calendar year 2016, and

BE IT FURTHER RESOLVED, that the filing of such agreement shall be made according to the terms of the resolution hereby approved.
