#### DISCUSSION

The Sales Tax report for the month has not been received yet and the Mortgage Tax was \$20,933.93.

The Zoning Administrator has asked the Town Board to review and approve a new Zoning Fee Schedule. He has proposed changes to: fees for storage sheds/buildings, solar panels, permit renewal, title/zoning violation searches, septic systems, and curb cuts to Town Roads. Councilman Grasso asked if the Town can charge fees for title/violation searches, or are those requests covered by FOIL. He said that he would like more time to

review the proposed changes. Attorney Van Vranken suggested that the Board be ready to approve the changes that they would like to make by the January 9<sup>th</sup> meeting, so that fees could be retroactive to January 1.

The Board will look at the fees charged for water to see if adjustments are needed.

Councilman Grasso said that he met with Eran Wasserman from The Route 67 Country Store. Mr. Wasserman said he has been changing the scope of his business including removing the gas pumps, and discontinuing the sale of many convenience store items. He currently sells food, specialty beers and teas. He would like to sell beer and wine by the glass to customers that come in to eat. It was noted that the property includes a house and a store, each having a separate septic system, but sharing water. Attorney Van Vranken said in his opinion, Mr. Wasserman needs to go before the ZBA to seek a variance for what he wants to do. Councilman Grasso said that he would get more information.

Supervisor Grattidge said that he will have information from the bookkeeper for the next meeting to close out the accounts for 2016.
