The Agenda Meeting of the Town Board of the Town of Charlton, Saratoga County, New York was held at the Charlton Town Hall, 758 Charlton Rd, Charlton, NY and called to order by Supervisor Grattidge at 7:30 p.m. to set the agenda for the April 13th Meeting.

RESOLUTION #82 Abstract of Claims

The Town offices will be closed April 3rd in observance of Good Friday.

The Highway Department will do spring brush pick-up the week of April 27 – May 1.

DISCUSSION

The Sales Tax report for the month was \$89,303.00 and the Mortgage Tax was \$4,261.50.

The Supervisor has provided the Board with the monthly Bank Reconciliation report. He also confirmed that the Town received the Key Bank custodial statement.

Supervisor Grattidge said that National Grid did an energy audit of Town Hall and did not feel that upgrades needed to be made. Their audit of the Highway Garage found many items that could be changed. National Grid will put together a recommendation of upgrades for the Highway Garage.

The heating contractor for the Town Hall will start installing the new heating coils on March 31. Once the heating system is up and running, the repair and repainting of sheetrock will be done. The insurance company has approved the estimate for the repair work.

The Parks Committee and Councilman Lippiello are in the process of getting quotes for the base installation for the new gazebo for Gideon Hawley Park. They are waiting on an electrical quote. A second public hearing will be needed before money can be expended for the installation of the gazebo. The funds will come from the Parks Repair Reserve Fund, which has ample funds for the entire project.

Councilman Lippiello said that the new footbridge in Elmer Smith Park is near completion. The Highway department is working on the grading around the bridge and the electrical that runs under it.

Supervisor Grattidge said that he has spoken with each of the Board members over the past weeks regarding the issue with chickens and small animals and the zoning changes. The Board has decided to strike the proposed changes regarding chickens from the current proposal for zoning changes. The Board will continue to work of this issue in the future as a separate item.

Councilman Grasso said that he has sent the proposed zoning changes to the NYS Department of Ag & Markets for their review.

Supervisor Grattidge said that previously the Town Board had discussed the possible easement in the Deer Run subdivision that would give the Town access to the Alplaus and space for a possible parking lot in the future. The easement language had been sent to the Planning Board Attorney and the Town Attorney for review.

Councilman Lippiello asked if the Board had heard anything from Verizon regarding the antenna for the water tower. Attorney Van Vranken said that he has reviewed the lengthy contract, and he has also reviewed the contract that Verizon has with the Town of Ballston. He has found some difference in the contracts. Attorney Van Vranken suggested that Board begin meeting with Verizon and let them know what they do and do not like in the contract. Supervisor Grattidge said that he has heard from Verizon and they are very interested. He would like to meet with Verizon along with Councilman Grasso and Attorney Van Vranken. Councilman Grasso said that the Board may want to consider hiring a consultant to act on the Town's behalf. He is familiar with other parties that have used consultants and they have been very useful, I as there are many issues to be worked out. Councilman Hodgkins suggested that there be screening done around the out building that would be installed.

WHEREAS, the Town Attorney has reviewed the Deed of Easement and one other required document (TP-584) and also reviewed the Deed of Easement description which includes certain rights of the Town of Charlton related to the establishment of a parking area within the Deed of Easement description should the Town Board determine now or in the future that such access parking area would be in the best interests of the residents of the Town of Charlton, and

WHEREAS, the Town Attorney recommends the Supervisor to execute the required document necessary for recording of the Deed of Easement in the Saratoga County Clerk's Office.

NOW BE IT RESOLVED, that the Town Supervisor is hereby authorized to execute whatever documents are required to complete the transfer of the Deed of Easement from the Deer Run of Charlton Homeowners Association, Inc. to the Town of Charlton.
