## ANNOUNCEMENTS

The Town Board will hold a Workshop on Thursday, August 20<sup>th</sup> at 7:00 p.m. to discuss proposed zoning changes.

The date for the August Town Board Agenda Meeting has been changed to Monday, August 24<sup>th</sup>.

Supervisor Grattidge said that the Town received notice that our Equalization Rate is now 72%. A chart of other Town's rates was included and showed that Charlton is about in the middle of percentages. The Board discussed that a revaluation will need to be done in the future.

## **DEPARTMENT & COMMITTEE REPORTS**

Constables – In July, there were 28 patrols, 12 complaints, 7 911 calls, 1,800 miles traveled, 33 tickets issued, 4 accidents responded to and 4 EMT calls.

Highway – Councilman Hodgkins said that there is a pavement management program called Cornell Local Roads Program (CLRP) that the Town can buy. The software program is used to keep information about the Town's roads and can used for road evaluations, reports, etc. It is suggested that a college engineering student be hired as an intern to implement the software and enter the data. Supervisor Grattidge suggested that Councilman Hodgkins get the costs together to be considered at budget time.

Historian – Mr. Livingston said he has been busy helping a few families with genealogy research. He also asked about doing a Town Newsletter, and offered to do an electronic newsletter that can be emailed to residents. He will work with the Town Clerk on this.

Planning Board – the Board met on July 20th, where 2 subdivision applications were considered. There will be two Public Hearings on August 17<sup>th</sup> for a 2 lot subdivision on Packer Road, and a 3 lot subdivision on Jockey St.

ECC – Marv Schorr said that the Committee has reviewed the Packer Road subdivision and they have questions and comments.

Charlton Seniors – Marv Schorr said that the Senior's annual picnic will be held August 12<sup>th</sup>.
