### SUPERVISORS REPORT

For the month of September, I attended 3 Town meetings and 7 County meetings. Some of the highlights of the month:

- Attended normal Town and County meetings
- Worked on preparing the 2016 Town Budget
- Worked on the Saratoga County 2016 Budget
- Worked on the County takeover of the LFTC public road system
- Spoke at the New Gazebo Dedication Ceremony

Supervisor Grattidge said that the Board had received financial printouts.

#### ANNOUNCEMENTS

The Town-wide brush pick-up will be the week of October 26<sup>th</sup> through October 30<sup>th</sup>. Brush should be curbside by October 25<sup>th</sup>. The Town will not pick up trees that have been taken down by contractors or tree services.

#### COMMUNICATIONS

The Town Board has received one quote for seal coating and line painting the Town Hall parking lot. The price was \$3,000.00. The Highway Superintendent is still gathering quotes and will put a packet of quotes together for the Board. The work will most likely take place in the summer of 2016.

#### **DEPARTMENT & COMMITTEE REPORTS**

Supervisor Grattidge thanked Councilmen Gay and Lippiello for conducting the Town audits recently. Councilman Gay said that all of the Departments records were impeccable.

Maintenance – Don Smith trimmed shrubs around Town Hall and removed debris, purchased and replaced light bulbs at Town Hall, vacuumed basement stairwells, as well as maintenance at the Community Center.

Constables – In September, there were 23 patrols, 18 complaints and 1 EID responded to, 4 911 calls, 1,743 miles traveled, and 47 tickets issued.

Zoning – In September there were 9 Building Permits issued and \$810.00 was collected in application fees. 12 CO/CUs were issued with a total value of \$3,899,208.00.

Mr. Emerich stated that he was awarded the sand screen from Federal Surplus, but did not get the mower.

Greater Galway Food Pantry – a copy of their September meeting minutes was received and is on file in the Clerk's Office.

Historian – Marv Livingston asked the Board if they would consider a commemorative plaque for Frank Lafforthun to be placed in Gideon Hawley Park. Mr. Livingston said that Frank was the builder of the original gazebo and the park. Supervisor Grattidge asked Mr. Livingston to get quotes for a plaque.

Galway Emergency Services – Supervisor Grattidge said that they provided the Board with a copy of a map that shows their coverage area in Charlton. The Supervisor asked the Town Clerk to contact them for a better copy of the map and put in on the Town's website.

Councilman Grasso asked Mr. Emerich to get the costs for the road reconstruction and the crack sealing that were recently expended, and keep it handy to be put into the Highway Road software.

Councilman Grasso said that he, Supervisor Grattidge and Attorney Van Vranken met with Aerosmith Development who is considering an application for installation of cell tower equipment on the water tower. The next step is to put a draft lease agreement together and do a site visit with their engineers. The Councilman will keep the Board apprised of any progress.

Councilman Grasso gave the Board an updated Fund Balance Ledger which basically shows a summary of all of the Town account balances. His report includes a graph for the Board to track the Fund Balances month to month and year to year. He will update the report each month. He also included a chart of all of the outstanding bonds that the Town has. The report shows a cumulative total of all the bond amounts and shows what the bond liabilities will be from 2015 through 2024, when all of the current bonds will be paid off. After 2020 the bond payments drop off dramatically.

Supervisor Grattidge said that a contractor that is working on private wells in Charlton and is in need of water for his tanker. The State requires that he use treated water. He has asked the Town if he can purchase the water from the Town. Supervisor Grattidge said that in 2012 at a Water Board meeting, the Town passed a policy that the Town would sell water for \$10 per 1,000 gallons when water was needed by contractors.

#### **RESOLUTION #169**

### Resolution to authorize the Water Superintendent to sell water to Rozak and Company

Motion by Councilman Grasso Seconded by Councilman Hodgkins

Discussion: Councilman Hodgkins suggested that the system flushing be done when the tanker is filled. Councilman Grasso said that he would just request that the Water Superintendent be present when tanker is being filled. Councilman Hodgkins asked Mr. Morgan is he uses a backflow preventer. Mr. Morgan said that he does not, but agreed that it would be a good idea.

BE IT RESOLVED that the Town Board hereby authorizes the Water Superintendent to coordinate the sale of water to Rozak and Company at a rate of \$10 per 1,000 gallons.

Supervisor Grattidge said that at the Budget Workshop, the Galway Ambulance Squad had an additional request for 2 EKG monitoring machines which cost about \$70,000 each. The Ambulance Corp has approached the Town of Galway and the Town of Providence for additional money as well. Supervisor Grattidge has spoken with the Supervisors of these two Towns and has found that Galway is giving \$10,000 towards the purchase, and Providence has suggested splitting a \$5,000 donation with Charlton. Providence has more calls to the ambulance service and would donate \$3,000 and asked Charlton to donate \$2000. Supervisor Grattidge said he would suggest that the Town Board do a transfer out of the Contingency Fund this year as a donation to show that we are supporting them, but not add it to the amount contributed annually. Supervisor Grattidge said that the ambulance squad can possibly get a grant from the Dockstader Trust for one EKG machine, but the Squad would need to figure out how to obtain the rest of the money. Councilman Hodgkins said that the report from the Ambulance Squad shows that as of 9/22/15, there have been 180 calls in Galway, 72 in Providence, and 58 in Charlton. The Board decided not to take any action at tonight's meeting.

### **COUNCILMAN REPORTS**

Councilman Hodgkins said he is the process of updating a list of the Highway Department equipment, which he will make available to the Board when he is done.

### PRIVILEGE OF THE FLOOR

Judge Vern Ketchum thanked the Town Board for their support of grant application for the Town Court.

The meeting adjourned at 8:23 p.m.
