#### **DEPARTMENT & COMMITTEE REPORTS**

Constables – for the month of December, there were 26 patrols, 21 complaints, 8 911 calls, 1,621 miles traveled, 17 tickets issued, and 1 EMT/accident responded to.

Councilman Lippiello said that in 2013, the Constables did 309 patrols, responded to 236 complaints, traveled 21,247 miles and issued 364 tickets.

Zoning – Supervisor Grattidge said that the Zoning Office took in \$110 in special fees.

Water - Councilman Lippiello reported that John Morgan is doing painting at the pump house. Mr. Morgan is also waiting for information from the Engineer regarding a device that measures water when flushing the system.

Library – Barb Wilson stated that for the month of January, they have an Art Exhibit by the Schenectady Art Association in their community room and Judy Kaplan's penguins are on parade in their display case. The library is hosting a mini golf event on February 21<sup>st</sup> & 22<sup>nd</sup> with over 2 dozen business sponsors. In 2013, there were over 300 attendees.

Historian – Marv Livingston said that he has received pictures and stories for the town from Irene Jankowski regarding her property on Swaggertown Road. The property just so happened to be Mr. Livingston's family's homestead.

Parks – The Committee would like to come to the Agenda Meeting on January 27<sup>th</sup> to meet with the Town Board and discuss what the Board's expectations of the Committee are.

#### **COUNCILMAN REPORTS**

Councilman Lippiello welcomed the new Board members, Councilmen Grasso and Hodgkins.

#### PRIVILEGE OF THE FLOOR

Dave Schweizer, resident said that he attended a previous Board meeting and gave his opinion on gambling in Saratoga County, and is now shocked to see the Supervisor take the position as Chair of a group that is trying to entice gambling for Saratoga County. He said he looked at the vote, and it was 2 to 1 against gambling for the Town of Charlton. He asked the Supervisor if he felt he was representing the call. Supervisor Grattidge said for the record, he was named Chairman of the Racing and Gaming Committee at the County. He said he wasn't named Chairman of a committee that is supporting gambling. He does support the referendum, now that it is passed, that if it is going to be located in the 8 county region, that Saratoga makes the case to be a place where it is hosted. Mr. Schweizer said that he thinks that the people of Charlton are very concerned about the unintended consequences of such a happening. We are noted for a pretty historical community and the pressures that this will bring to us are probably going to change that very dramatically. He thinks that that needs to be looked at.
