#### **DEPARTMENT & COMMITTEE REPORTS**

Councilman Hodgkins reported that in March, there were 3 building permits issued for \$270.00 along with 2 CO/CC and 1 Property search fee collected for \$90.00

Councilman Verola - Dog Control - reported that there were 4 animal complaints: 3 dogs and 1 other. Planning - Deer Run 3<sup>rd</sup> phase is on hold waiting for soil tests & Charlton Tavern lot line change is waiting for special use permit approval.

Constables- Bob Lippiello reported that in March there were 41 patrols, 20 complaints; 3 accidents responded to and 2,028 miles traveled.

No update on Water Department

Highway- Mike Emerich stated that the snow and road sanding is hopefully behind them; they are spending time patching holes esp. Eastern Ave, cutting brush & trees; Worked on Machinery replaced all hoses on Backhoe.

-Received check for \$221.36 from Cummings Northeast. Mike questioned if this was refund from Councilman Hodgkins previous discussion with them Councilman Hodgkins will call company to inquire. Mike gave check to Town Clerk awaiting response for action. Councilman Grasso questions the plan for repairing pavement on Eastern Ave. Mike Emerich explained plan of grinding and filling in areas on pavement in need of repair.

Parks- Dave Pohl stated they have a 4/28 meeting scheduled and will be discussing repairs to the Gazebo along with requesting bids for 16, 18, & 20 foot gazebo to replace if that makes more sense than repairing. They want to make some repairs to the baseball field, fixing backstop, tightening up fences and ball field maintenance.

Supervisor Grattidge questioned whether the Little League could play on the fields, Councilman Lippiello stated the fields were relatively dry. Mr. Pohl stated there is a curl in the backstop that needs repair. Supervisor Grattidge stated our insurance wanted the fence to be capped off. Councilman Lippiello questioned where they wanted it capped and suggested that when Fence Company comes to look at repairs to have them quote capping also. Mike Emerich clarified how to repair fence. David Pohl also stated that the sand around the pitching mound is in need of replacement. Mike Emerich is aware and extra sand that is available will be used.

ECC- Marv Schorr announced that ECC is sponsoring a Roadside Cleanup on 4/26 from 8:00am-12pm and free tree seedlings giveaway from 12-1pm

Historian-Marv Livingston updated that they are waiting for the weather to turn warmer in order to be able to continue their restoration of the Jeremiah Smith Cemetery. He is still working on interesting genealogy of 3 main families in the Town of Charlton's History including the Smith and Holbrook families. The information is very interesting and it would appear they are all very related.

BOND RESOLUTION OF THE TOWN OF CHARLTON, SARATOGA COUNTY, NEW YORK, ADOPTED APRIL 14, 2014, APPROPRIATING THE AMOUNT OF \$158,000.00 TO PURCHASE A 2015 WESTERN STAR 4700 TRUCK VEHICLE, SNOW PLOWS, DUMP BODY AND ONE TARCO HIGHLANDER HL-HY2-10-SS SANDER, AND AUTHORIZING THE ISSUANCE OF \$158,000.00 SERIAL BOND OF SAID TOWN TO FINANCE THIS APPROPRIATION.

#### Recitals

WHEREAS, on April 14, 2014, the Town Board of the Town of Charlton approved a resolution authorizing the Town Highway Superintendent to purchase a 2015 Western Star 4700 truck, snow plows, dump body and one Tarco Highlander HL-HY2-10-SS Sander for use in the Town Highway Department and which purchase will require the Town Board to obtain bond or bond anticipation notes in the sum of \$158,000.00 to pay for said purchase.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF CHARLTON, IN THE COUNTY OF SARATOGA, NEW YORK AS FOLLOWS:

- Section 1. The Town Board hereby appropriates the amount of \$158,000.00 for the purchase of a 2015 Western Star 4700 truck, snow plows, dump body and one Tarco Highlander HL-HY2-10-SS Sander.
- Section 2. Serial bonds of the Town, or bond anticipation notes, in the principal amount of \$158,000.00 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.
  - Section 3. The following additional matters are hereby determined and stated:
- (a) The period of probable usefulness of the truck or purpose for which the bonds authorized by this resolution are to be issued, within the limitations of section 11.00(a)(29) of the Local Finance Law of the State of New York, is 5 years; the period of probable usefulness of the snow plows and dump body as set forth in Local Finance Law section 11.00(a)(28) is 15 years based upon the purchase price being greater than \$30,000.00; and the period of probable usefulness of the sander as set forth in Local Finance Law section 11.00(a)(28) is 5 years based the purchase price being less than \$15,000.00.
- (b) The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the Town for expenditures made after the effective date of this resolution for the purpose or purposes for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation section 1.150-2 of the United States Treasury Department.
  - (c) The proposed maturity of the bonds authorized by this resolution will not exceed five (5) years.
- Section 4. The faith and credit of the Town are hereby irrevocably pledged to the punctual payment of the principal and interest on said bonds and any notes issued in anticipation of said bonds or the renewals of said notes, and provision shall be made annually in the budget of the Town by appropriation for (a) the amortization and redemption of the bonds to mature in such year and (b) the payment of interest to be due and payable in such year.
- Section 5. Subject to the provisions of this resolution and of the Law, and pursuant to the provisions of section 21.00 relative to the authorization of the issuance of bonds with substantially level or declining annual debt service, section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals of said notes, Section 35.00 relative to bond resolution subject to permissive referendum and of sections 50.00 and 56.00 to 60.00 of the Law, the powers and duties of the Town Board relative to authorizing the issuance of any notes in anticipation of the sale of serial bonds herein authorized or the renewals of said notes and relative to prescribing the terms, form and contents and as to the sale and issuance of the serial

bonds herein authorized and of any notes in anticipation of the sale of said bonds or the renewals of said notes, are hereby delegated to the Supervisor, the chief fiscal officer of the Town.

Section 6. The validity of the bonds authorized by this resolution and of any notes issued in anticipation of said bonds, may be contested only if:

- (a) Such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
- (b) The provisions of the law which should be complied with at the date of the publication of such resolution, or summary thereof, are not substantially complied with, and an action, suit or proceeding contesting the validity is commenced within twenty (20) days after the date of such publication; or
  - (c) such obligations are authorized in violation of the provisions of the constitution.

Section 7. This resolution shall take effect immediately.
