Town of Charlton Saratoga County Town Board Agenda Meeting

April 28, 2014

The Agenda meeting of the Town Board of the Town of Charlton, Saratoga County, New York was held at the Charlton Town Hall and called to order by Supervisor Grattidge at 7:34 p.m. to set the agenda for the May 12th Town Board Meeting.

Present: Supervisor Grattidge, Councilman Grasso, Councilman Hodgkins, Councilman Lippiello, Councilman Verola, Town Clerk Brenda Mills, Attorney Van Vranken

RESOLUTION #95 Abstract of Claims

Motion by Councilman Verola Seconded by Councilman Hodgkins

Discussion: Councilman Grasso noted that the electricity usage in the highway garage was substantially higher than that same month in 2013. Highway Superintendent Emerich indicated that it is likely due to the use of engine block heaters and the excessively cold weather. Councilman Grasso asked if the amount that is paid to Williamson for support was typical, as he felt it seemed high. Supervisor Grattidge said that the support cost includes support for the Accounting, Water and Payroll modules, and that the bookkeeper quite often calls Williamson for support. The Town Clerk confirmed that the software support for her office is not included in this bill.

BE IT RESOLVED that the Town Board has approved the payment of bills as presented in Abstract No. 108, vouchers number 218 - 259 in the amount of \$37,210.68 and Abstract No.4, vouchers number 4 - 7 in the amount of \$1,174,659.60.

Discussion: Supervisor Grattidge said that in the Supervisor's Report, he met with DOT regarding Route 67, and asked that the minutes be changed to reflect that.

ANNOUNCEMENTS

The Town's bulk item pick-up by County Waste will be May 5th through the 9th. Metal can be dropped off at the Highway garage on Jockey St.

The Brush pick-up by the Town Highway Department is done for the spring.

The Sales Tax revenue for the month was \$120,619 and the Mortgage Tax for March was \$8,279.

DISCUSSION

The Town Board received a Special Use Permit application from Gadsden and Culpepper for the Heritage Shoppe, LTD. The Board can hear the application or pass it on to the ZBA and Planning Board to review. A resolution will be done at the end of the meeting to designate who will handle the application.

Highway Superintendent Emerich said that a major component on the department's backhoe has gone bad. He needs to repair or replace the swinger coupler. He stated that it would cost \$3,900 for replacement parts or \$3,100 for a whole new swinger coupler. He provided the Board with 3 quotes, the lowest being from Monroe Tractor for \$3,120.00 The Board will authorize the purchase later in the meeting.

Supervisor Grattidge said that in the years that an outside audit is not being done, the Town Board is responsible to annually audit the Town Departments that handle money. The Board uses an audit worksheet supplied by the Comptroller's office. Councilmen Verola and Lippiello will set up meetings with the 5 Department Heads that handle money, and then email the rest of the Board so that they can sit in on the audits if available.

Supervisor Grattidge said that the Bookkeeper is working early morning hours, as she has accepted another job.

Supervisor Grattidge said that he and Councilman Lippiello met with the Comptroller's Office representative about the audit that was done and the minor recommendations for the Water Department. Supervisor Grattidge said that he has prepared his response to the Comptroller's Office.

Supervisor Grattidge said that he has had an inquiry from a company that represents AT&T regarding putting antennas on the water tower to better the cell phone service for residents in this area. The phone company would be responsible for any damages to the paint and responsible to remove the antennas in the case of future repainting needs. This could create additional revenue for the water district, which could help to offset the cost of future paint jobs. Councilman Grasso asked if the revenue would be for the water district or the Town. Supervisor Grattidge said that it could be discussed further, as this is just a proposal at this point. The Board discussed the potential need for any additional modifications to the tower, such as additional lighting, which would need to be reviewed as part of any formal application. The Supervisor said that he was going to reach out to Verizon and Sprint about installing their antennas on the tower. John Morgan said that the FAA has to approve anything over 138 feet high.

Councilman Hodgkins said he has looked into another IT Company for the Town. Councilman Grasso asked if the Technology Committee could look into proposals. Supervisor Grattidge said it is ultimately the Town Board's decision. The Supervisor asked Councilman Lippiello to have Jim Leupold, member of the Technology Committee, look into whether or not the committee would be interested in assisting with it.

Councilman Lippiello said that he met with the Parks Committee and did a walk-through of Elmer Smith Park. There is a problem with the backstop fence. It is curling and turning in at the bottom. Bruce Fence, the original installer, gave an estimate of \$2,320 to remove and replace the bad section of fence, and suggesting replacing 9 supports at a cost of \$260. Councilman Grasso asked if there is a bottom rail to prevent curling. Councilman Lippiello said that he believes that there is. The Board will do an authorization later in the meeting. The Committee is also concerned about the safety of the footbridge for Party in the Park. The Board had no objection to having the Town Engineer inspect the bridge for safety.

Councilman Grasso asked if the Board wanted to move forward on the update of the Assessor's computers. Supervisor Grattidge said that this time of the year is the busiest for the Assessors, and as long as their computers are working okay right now, he would suggest that the update be done in June or July. The update needs to be done before next year to communicate with the County RPS system.
