The Town Board tabled the approval of the Agenda Meeting minutes from July 28, 2014, as Councilman Verola was not present at that meeting, and there was not a quorum present for approval.

SUPERVISORS REPORT

For the month of July, I attended 2 Town meetings and 5 County meetings. Some of the highlights of the month:

- Attended the Saratoga County Fair

ANNOUNCEMENTS

The Sales Tax for the month of July was \$141,022.00 which is 4% higher than last July, and year to date is 2.94% higher than this time last year.

Supervisor Grattidge confirmed that the Board has received the Key Bank Custodial Statements.

COMMUNICATION

Supervisor Grattidge has received official notice that the Final Equalization rate for Charlton for 2014 is 71%.

Supervisor Grattidge said that the Assessor's Office has sent a memo to the Board saying that they are experiencing problems with their computers. They will need new pc's with an updated operating system in order to communicate with the Office of Real Property next year. The Board will need to work on this.

Supervisor Grattidge said that a resident inquired about the Zoning Ordinance updates. The Board has had a workshop and Councilman Grasso is working on the updates. The Supervisor said that he hopes to have something to post on the website within the next month. He is hoping to have an informational meeting soon, and get feedback from all of the committees, the public and if the Board is comfortable, a public hearing will be held. He hopes that something will be in place by next year.

Supervisor Grattidge said that he has sent a request to the State Department of Transportation, requesting that the State look at placing a blinking light at the intersection of Route 67 and Jockey Street.

DEPARTMENT & COMMITTEE REPORTS

Zoning – Councilman Hodgkins said that in July, there were 15 building permits issued and 3 CO/CUs were issued.

Historian – Marv Livingston said that he has been working on a database of Charlton, and recently Chuck Latham gave him a database that was done by Joyce Riedinger. He found the information helpful. He said that he and Boy Scout Nick Bruno have begun the restoration of headstones in Jeremiah Smith cemetery, and the restoration is going well. There are many headstones that needed to be up-righted, and there are many broken stones that needed to be patched. They received suggestions for restoration from the Jonesville Cemetery. They are using an epoxy that seems to be working well. Nick's mother and sister have been working on cleaning some old headstones that were so dirty that they could not be read. The headstones cleaned up well, and are now legible. Mr. Livingston said that Aubrey Dunn and her mother Liz had previously finished photographing the head stones, but since they are more legible now, he wants to ask them to re-photo them. He said that the next cemetery that he and Nick will work on is Pine Grove, where they plan to make a mock cemetery of the headstones that were moved from the Presbyterian Church.

Planning Board – Councilman Verola reported that the Board met on July 21st and deliberated on 1 lot line change application and 1 subdivision application.

Animal Control – Councilman Verola reported that in July there were 6 dog related complaints and 1 dog bite case handled.

Constables- Supervisor Grattidge read the July report. There were 26 patrols, 21 complaints, 3 911 calls, 19 tickets issued, 2 EID calls and 1,562 miles traveled.

Seniors – Marv Schorr reported that the Senior's annual picnic scheduled for Elmer Smith Park on August 13, will be moved to the Community Center because of the weather forecast.

BE IT FURTHER RESOLVED, that the salary for Assessor Victoria Hayner shall be at the rate of \$5,400.00 per year, pro-rated from September 1, 2014 until December 31, 2014.

RESOLUTION NO. 142

A RESOLUTION PROHIBITING ANY OVERNIGHT PARKING IN THE TOWN HALL PARKING LOT WITHOUT TOWN BOARD APPROVAL

WHEREAS, from time to time, the Town Supervisor or members of the Town Board have received requests from Town residents to park vehicles overnight in the Town Hall parking lot located northerly and behind the Town Hall building, and

WHEREAS, there have been occasions where such vehicles have included large transport trucks or other types of oversized vehicles having substantial weight or containing materials that are were en route for delivery outside the Town of Charlton, and

WHEREAS, residents of the Town have expressed concern to Town Board members of this activity, including issues of safety, Town liability and damage to Town property, and

WHEREAS, the Town Board has considered this matter and determined that it is in the best interest of the residents of the Town of Charlton to prohibit any and all overnight parking of vehicles not specifically associated with the local governmental activities for the Town of Charlton (Constable vehicles, etc.).

NOW THEREFORE, BE IT RESOLVED, that the Town Board hereby determines that there shall be no overnight parking in the Town Hall parking lot as referenced in this resolution without the express authorized and written permission of the Town Board of the Town of Charlton, and

BE IT FURTHER RESOLVED, that violators of this resolution may be subject to fines or other penalties as may be solely determined by the Town Board in its sole and absolute discretion.
