### **DISCUSSION**

The Sales Tax for the month was \$89,179.00 and the monthly Mortgage Tax was \$13,799.00

The Town Board received a package of information from Brian Bold, the Director of the Burnt Hills Ballston Lake Summer Rec program. He reported that there were 26 children from Charlton that participated in the 2012 program, 50 from the Town of Glenville and 51 from the Town of Ballston. Supervisor Grattidge said that the Town Board set aside \$3,000 for the program at budget time, and of that money, the Town is reimbursed about 1/3 from the County. Councilman Salisbury said that he has spoken with Charvale Pool about the program and he has spoken with Mr. Bold and is satisfied. The Town Board was in support of the program.

# A RESOLUTION TO SUPPORT THE ZIP CODE BOUNDARY REVIEW REQUEST LETTER SUBMITTED BY ZIP CODE COMMITTEE MEMBERS AT THE MARCH 11 REGULAR MEETING OF THE CHARLTON TOWN BOARD

WHEREAS, a committee of Town residents, concerned with issues relating to multiple zip codes affecting residents of the Town of Charlton, but not identifying the Town of Charlton as a destination location for any of the zip codes resulting in mail delivery to such residents, has formed a Zip Code Committee in order to attempt to address the issue, and

WHEREAS, a presentation was made to the Town Board at the regular meeting of the Town Board held on March 11, 2013, at which time a document entitled "CRS Report for Congress: Changing Postal Zip Code Boundaries" and a document entitled "Zip Code Boundary Review Request" were both presented to the Town Board for consideration, and copies of which documents are attached to this resolution and considered to be a part of the information considered by the Town Board membership in setting forth the terms described herein, and

WHEREAS, the primary concern addressed by the Committee relates to zip codes 12010 and 12302, which respectively affect the Town of Charlton, Saratoga County, the Town of Amsterdam, Montgomery County and the Town of Glenville, Schenectady County, resulting in mail and package deliveries to erroneous destinations as well as calculation of sales tax percentage rates on purchases, using the incorrect county rate for properties having the referenced zip codes in the Town of Charlton, and

WHEREAS, following the presentation by members of the Committee, a request was made for the

Town Board to approve a resolution supporting the request set forth in the document entitled "Zip Code Boundary Review Request" dated March 11, 2013, and

WHEREAS, members of the Town Board have reviewed the documentation presented by the Committee, are fully aware of this issue which is of long-standing concern and annoyance to the residents of the Town of Charlton and are willing to assist this Committee in attempting to resolve the matter by achieving the goal of obtaining new zip codes for those properties located within the Town of Charlton, Saratoga County currently affected by the referenced current zip codes 12010 and 12302.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Charlton hereby supports in all respects the proposed letter prepared by the Charlton Zip Code Committee and authorizes the Committee to attach a copy of this resolution to its submission to the Manager of the District of the United States Postal Service (USPS) having jurisdiction of this issue and request.

#### **COUNCILMEN COMMENTS**

Councilman Verola said that the newsletter is almost done. It is longer than the previous newsletter, so it may exceed the budgeted cost.

Councilman Lippiello said that the Party in the Park Committee has arranged to have the Boothill Band provide music for the event. They are looking for a climbing wall.

Councilman Gardner asked Supervisor Grattidge if the Public Sector Consulting Service price quote for service is still good. The Supervisor said that the prices are still the same, but he feels that the hourly rate is too high. Councilman Verola said that she thinks that the Board should consider hiring them to be the Town's Human Resource Department. The Supervisor suggested that with limited funds, the Board probably needs to decide what the HR priorities are first and then contact them.

Councilman Gardner asked when the Board was going to audit the 2012 Town books. Supervisor Grattidge said that they should probably do it in the next month, and asked Councilman Verola to head that up.

Attorney Van Vranken said that today he sent the Board a copy of the new Local Law that he proposes for stand alone solar panels. He asked the Board to review it, and he also sent a copy to the Zoning Administrator. He said to get the law passed it would take about 2 months.

The meeting adjourned at 8:07 p.m.
