# Town of Charlton Saratoga County Town Board Agenda Meeting

### **ANNOUNCEMENTS**

The annual Saratoga County Planning and Zoning Conference will be held January 26, 2011 at the Saratoga Hilton. Any Town officials or Board members interested in attending need to submit their reservations.

## **DISCUSSION**

The Mortgage tax for October was \$12,508. The 6-month distribution for April to September is \$59,743.41.

A rough draft of the new usage policy for the Community Center was prepared by the Town Clerk's office and given to the Board. The Board will review the policy and schedule a workshop to discuss their suggested changes.

Supervisor Grattidge said that neighboring Towns use the school districts snow day schedule for their employees and he asked the Board if they would like to institute the same policy for Charlton. Councilman Salisbury said that the school's snow days are for the safety of the students. The Town employees are adults and should be able to make it in to work. Councilman Gardner felt that the schools tend to be more liberal than the Town would need to be. The Board decided that there was not a need for a Town policy.

Supervisor Grattidge had a request from Saratoga P. L. A. N. to have the Town of Charlton volunteer to be part of a case study for the Transfer of Development Rights. He believes that basically the plan is to have Towns set up desired areas for allowing building, and then once that area is purchased for building, fees would be used to by the development rights of farm land. The Supervisor will set up an informational meeting for the Board with Saratoga P. L. A. N.

A Town Board workshop has been scheduled for December 8<sup>th</sup> at 4pm to draft the 2011 Organizational Resolution. A Special Board meeting has been scheduled for January 3, 2011 to approve the Organizational Resolution.

In October 2010, the Town Board authorized the purchase of a sound system for the Town Hall meeting room. The Technology Advisory Committee has now made a recommendation for the recording device and playback system to be used with the sound system. The cost of the additional recording technology is \$1,610.25.

A *motion* was made by Councilman Verola and seconded by Councilman Lippiello to authorize the Supervisor to purchase the recording device and playback system with a price not to exceed \$1,700.00

Supervisor Grattidge said that he has met with the Town of Glenville regarding sharing the services of their Dog Control Officer. Glenville would accept Charlton's budgeted amount for Dog Control.

Supervisor Grattidge said that he has had discussions with an individual who would be interested in combining the services of Zoning and Building.

Supervisor Grattidge said that the Communications Committee put on a very interesting presentation for the Board of the remapping of the Town website. Councilman Verola felt that what was presented was very impressive and that the price to do the remapping was very reasonable. She and Councilman Gardner were concerned about the annual \$2,400 ongoing maintenance fee. Councilman Lippiello said that the \$2,400 includes hosting, webmaster, storage of all content on their system. Councilman Verola said that she would like to get the opinion of E-Nable.
