Town of Charlton Saratoga County Town Board Agenda Meeting

December 28 2010

The Agenda meeting of the Town Board of Charlton, Saratoga County, New York was held at the Charlton Town Hall and called to order by Supervisor Grattidge at 7:35 pm.

Present: Councilman Gardner, Councilman Lippiello, Councilman Salisbury, Councilman Verola, Supervisor Grattidge, Town Clerk Brenda Mills, Attorney Robert Van Vranken

Supervisor Grattidge announced that this meeting is to set the Agenda for the regular meeting of the Town Board on Monday, January 10, 2011.

APPROVAL OF ABSTRACT

A motion was made by Councilman Lippiello and seconded by Councilman Verola to accept General Fund Claim numbers 1810 to 1876 as set forth in Abstract 124 in the amount of \$70,162.60, and General Fund Claim numbers 927 to 939 as set forth in Abstract 99112 in the amount of \$2,811.80.

Discussion: Councilman Verola questioned the Town's policy regarding needing authorization to purchase items over \$300, and asked if the policy should be revamped as one of the Departments ordered several tools each under \$300 but totaling \$1326, without authorization. She felt that this left the Board no option other than to rewrite the Town's policy or have the items returned. Councilman Gardner said that it is not what the items are that are of importance, but rather the total of the items should need authorization if it is over \$300. Supervisor Grattidge asked Highway Superintendent Mike Emerich for an explanation. Mr. Emerich stated that he purchased wrenches, screwdrivers, etc., all items that he needed, and none of the items were over \$300. Councilman Verola said that she felt that \$1,300 in tools on the very last abstract of the year may not have been totally necessary. Mr. Emerich was asked if since he had extra money in this line, did he consider using it for his fuel line that did not have enough money. Supervisor Grattidge said that along the same line the Highway Department built their own sanding box without informing the Board or coming to the Board about it. The Supervisor said that he felt that the communication has broken down between the Highway Department and the Town Board. Supervisor Grattidge said that Highway Superintendent needs to do a better job of turning in vouchers for payment in 2011, as many vendors were paid several months late, and the fuel company was threatening to discontinue service to the Town for nonpayment.

ANNOUNCEMENTS

The annual Saratoga County Planning and Zoning Conference will be held January 26, 2011 at the Saratoga Hilton.

The annual Association of Towns meeting will be held in February if any Town Board members wish to attend.

Councilman Verola said that she had previously asked to discuss the website update with Enable. Mrs. Verola said that she has a list of questions from her son who is a software professional, and she would like to discuss them with Enable also. She and Councilman Lippiello will handle and report back to the Board.

Supervisor Grattidge said that the Board has received an application for a Special Exception Permit for a Riding and Stable Academy on Jockey Street from Eric and Kim Cowley. They are applying for a permit to build an enclosed ring. The Town Board can choose to hear the case or pass it on to the ZBA.

A *motion* was made by Councilman Verola and seconded by Councilman Lippiello to authorize the Town Board to hear the Cowley case for a Special Exception Permit.

Supervisor Grattidge suggested that since the existing site plan was previously handled by the ZBA, that the Town Board allow the ZBA to handle this application.

A *motion* was made by Councilman Verola and seconded by Councilman Salisbury to send the Fred Ogle's application to be heard by the ZBA.

DISCUSSION

The sales tax for the month was \$90,228 and the November mortgage tax was \$13,172.

The Supervisor said that Attorney VanVranken had drafted a Use Policy for the Community Center. The Board felt that they should hold a workshop to discuss the changes.

Maria Traska from Saratoga P.L. A. N. was present at the meeting to discuss the transfer of development rights with the Town Board. Ms. Traska said basically the concept is to take the rights of development from one area and transfer them to another predetermined area. She stated that for this to be warranted, the Town needs open space as well as development pressure. The Town Board will put together a list of questions in January.

Supervisor Grattidge said that the old Minolta copier in the second floor copy room is in need of parts and service and there is no maintenance agreement currently in place for it.

A *motion* was made by Councilman Verola and seconded by Councilman Lippiello to authorize Eastern Copier to repair the copy machine for a cost not to exceed \$715.00.
