PRIVILEGE OF THE FLOOR

Dave Wood said that a few years ago a survey was done and the majority of Charlton residents wanted to keep farming, farmland and open space in Charlton. He pointed out that he only owns about 1/3 of the land that he farms, and rents the rest from landowners.

Dave Stafford of Peaceable Street said he thinks that this is great. It is good to preserve the Agricultural land that we have. He applauds all the effort that went into this project.

Torben Aabo said he thinks that the committee did an excellent job.

Supervisor Grattidge said that there is a difference between open space and farmland, and the Town is concentrating on working farmland. This is a balancing act and something that the Town will have to keep working on.

Dave Stafford said that there was a newspaper article about a bridge being built connecting to Route 5 on the Mohawk. If this bridge goes near Charlton, it would put a lot of pressure on the Town.

Bob Lippiello thanked everyone who worked on the plan.

A motion was made by Councilman Salisbury and seconded by Councilman Lippiello to close the Public Hearing.
