June 14, 2010

The Regular meeting of the Town Board of Charlton, Saratoga County, New York was held at the Charlton Town Hall and called to order by Supervisor Grattidge at 7:30pm.

#### **COMMUNICATIONS**

A letter was received from Congressman Scott Murphy's office concerning the 115kV transmission project by National Grid. He stated that he is aware that there are concerns from residents of several towns in his district. He has encouraged all entities involved to be cooperative and give residents the opportunities to voice their concerns. A copy of the letter is attached with all of the National Grid documentation in the Clerk's office.

Time Warner sent the Supervisor a letter informing him that a few channels will be repositioned.

A notice was received from New York State stating that the CHIPS money has been authorized to be released. The CHIPS money is for local highway programs. He also mentioned that he has documentation from New York State regarding early retirement for any employees that might be interested.

Supervisor Grattidge stated that the Town Board received a FOIL request from David Milne for budget, bond repayment and the Town's Annual Report. He turned the request over to the Town Clerk for processing.

Supervisor Grattidge received a letter from the Assessment Review Board and read it into the record. The letter addressed the grievances filed this year. A copy of the letter is attached.

#### **DEPARTMENT & COMMITTEE REPORTS**

Zoning – For May, 7 building permits were issued and 15 Certificates of Occupancy.

Communications – Chairwoman Lovie Bourne offered condolences to the family of Peter Olsen, who was a member of the Communication Committee and recently died while on a trip in New Mexico. She stated that the Committee is currently working on site mapping for the Town's website.

Planning – The Board met on May 17<sup>th</sup> and deliberated on 2 subdivision applications, and gave updates on 2 major subdivisions.

Constables – For the month of May there were 29 patrols.

Re: 2010 Board of Assessment Review Summary of activities

Dear Supervisor Grattidge,

On May 18<sup>th</sup> the BAR members met with Charlton Town Assessors Lewis Morris and Rachel Holbrook. We wanted to get a sense of what we would dealing with on Grievance Day. Lewis had been contacted by a number of Charlton residents regarding primarily clerical errors and a few unequal or excessive assessments. These resulted in 14 "adjustments": 8 corrections to inventory, 4 errors in essential facts, and 2 late senior citizen exemptions.

During our afternoon and evening Grievance sessions, we met with 12 Charlton residents, presenting 13 grievances based on unequal or excessive assessments. Residents have information on grievance procedures available to them. However, some either don't know this or don't bother to provide the required supporting data for their grievance. Later, Lewis was able to provide additional supporting data where needed for our deliberations.

The BAR met at the Charlton Community Center on June 1<sup>st</sup> for 4 hours and again on June 3<sup>rd</sup> for 3 hours. Our deliberations and final decisions were more difficult and time consuming than usual. Of the 13 grievances we lowered 6 assessments, 7 have no change in assessments, 2 of them because they did not own the property by the taxable status date of March 1<sup>st</sup> 2010.

I did the required paperwork and mailed our Determinations on June 7th. On June 10<sup>th</sup> I gave a Summary of Determinations to Lewis with a copy for the Saratoga County Real Property Tax Services and turned over all the original paperwork to Town Clerk Brenda Mills.

As stated last year, once again the process has highlighted the fact that Charlton needs a complete reassessment. Again it became very evident that there are too many assessment inequities, both too low and too high. The disparity increases each year. Also as stated before, we are strongly in favor of a single, well-qualified assessor.
