Chelsea, Massachusetts, January 10, 2011

A Regular Meeting of the Chelsea City Council was held. The meeting was held at the Chelsea City Hall, located at 500 Broadway, Chelsea Mass. The following members were in attendance: Councilors Robinson, Hatleberg, Cortell, Washington, MeKonnen, Barton, Brown, Bishop, Vega-Torres, Bongiovanni, and Maronski. Senior member, Councillor Robinson presided over the meeting. The meeting opened at 7:00 P.M.

Prior to the start of the meeting a moment of silence was conducted for the victims of the Tucson, Arizona shootings.

Councillor Robinson then opened nominations for President of the City Council for the year 2011 under suspension.

Councillor Robinson nominated Councillor Vega-Torres. Councillor MeKonnen seconded the nomination. Councillor Brown closed nominations. On roll call Councillor Vega-Torres was elected President of the City Council 11-0-0-0. Voting for Councillor Vega-Torres were: Councilors Robinson, Hatleberg, Cortell, Washington, Barton, Brown, Bishop, Vega-Torres, Bongiovanni, and Maronski.

Councillor Robinson opened nominations for Vice- President. Councillor Vega-Torres nominated Councillor Bongiovanni. Councillor Brown seconded the nomination. Councillor Robinson closed nominations. On roll call Councillor Bongiovanni was elected Vice-President of the City Council 10-0-0-1. Voting for Councillor Bongiovanni were Councilors: Robinson, Hatleberg, Cortell, Washington, MeKonnen, Barton, Brown, Bishop, Vega-Torres, and Maronski. Councillor Bongiovanni voted present.

City Clerk Deborah Clayman administered the Oath of office to Councillor Vega-Torres and Councillor Bongiovanni.

Newly Elected President of the City Council Councillor Vega-Torres addressed those in attendance and then opened nominations for the Delegate to the School Committee. Councillor Bongiovanni nominated Councillor Washington. Councillor Hatleberg seconded the nomination. Councillor Brown closed nominations. On roll call Councillor Washington was elected delegate to the School Committee 10-0-0-1. Voting for Councillor Washington were Councillors Robinson, Hatleberg, Cortell, MeKonnen, Barton, Brown, Bishop, Vega-Torres, Bongiovanni, and Maronski. Councillor Washington voted present.

City Clerk Deborah Clayman administered the oath to Councillor Washington.

Councillor Robinson moved that the seating positions and the roll call positions as drawn in the Sub-Committee on Conference be the seating and roll call positions for the year 2011, by roll call. The roll call passed 11-0-0-0. Voting yes were Councilors Robinson, Hatleberg, Cortell, Washington, McKonnen, Barton, Bishop, Vega-Torres, Bongiovanni, and Maronski.

Whereas, Dr. King's life will always shine as a light for those without hope and as

an example to be emulated by all who care about their fellow human beings, regardless of race, religion, class or nationality; now, therefore, be

Reverend Dr. Martin Luther King, Jr. Day in the City of Chelsea and ask all citizens to reflect upon the significance of this extraordinary man's life.

A copy of a report was submitted regarding the Charter Review dated December 13, 2010 from Councillor Hatleberg. A motion from Councillor Hatleberg to accept and file was adopted under suspension.

Second Readings:

The Order submitted by Councillor Vega-Torres requesting an organizational meeting for January 3, 2011 was withdrawn at the request of Councillor Vega-Torres.

New Business:

The following Order was introduced by Councilors Hatleberg and Brown. A motion from Councillor Brown to adopt by roll call passed 11-0-0-0. Voting yes were Councilors Robinson, Hatleberg, Cortell, Washington, MeKonnen, Barton, Brown, Bishop, Vega-Torres, Bongiovanni, and Maronski.

Resolved, that the Chelsea City Council reaffirms and accepts the report of the sub-committee to evaluate the City Manager.

A moment of silence was conducted for the passing of Dan Robinson Jr. at the request of Councillor Robinson, and Michael Callahan at the request of Councillor Brown.
