Re: Acceptance of Gifts and Donations

The following communication was read from City Manager Jay Ash. A motion from Councillor Hatleberg to accept and file was adopted under suspension. Councillor Bongiovanni recused herself due to a possible conflict of interest. Dear Ladies and Gentlemen of the Council: The Chelsea Senior Center has received an unsolicited grant from the Chelsea Community Fund to have a Senior Center Gardening Project in the amount of \$5,000, \$2,000 of which goes directly to the Senior Center (with the remaining \$3,000 going to the Chelsea Community Gardens, which is not a City entity). The grant is for a project between the Senior Center and Community Gardens to fund a community garden on the roof of the Senior Center. The Chelsea Community Fund is a private entity and therefore all such grants should be accepted as gifts by the City Council.

Pursuant to Massachusetts General Laws and the City of Chelsea's Ordinances; the City Council must formally accept this gift. This \$2,000 donation offers significant move towards the Senior Center's project of promoting gardening which will be designed for older gardeners and for those without yard space.

I would appreciate it if the Council would take action and approve the acceptance f this gift.

Re: CIP Reprogramming Request: Fire Engine #3-Mill Hill Station Renovation.

Ladies and Gentlemen of the Council:

In 2009, the Chelsea Fire Department secured a federal grant of \$1,515,020 for the renovation of the Mill Hill Station at 883 Broadway. Chelsea was one of only two Massachusetts Communities to secure an award from the FEMA/Department of Homeland Security (DHS) Firefighters Station Construction Grant program in the 2009 federal funding cycle. Our award is all the more fortunate in that there has been no subsequent funding cycle from this program.

The City's grant proposal included a local match commitment of \$373,755 for a total project cost of \$1,888,775. Additional expenses not covered under the grant/match include Clerk of Works, and most Furniture, Fixture and Equipment for the renovated station.

The scope of work proposed for the Mill Hill Station is the renovation of the 1887 building with improvement to meet contemporary firefighting demands. Improvements include structural upgrades to the 1937 apparatus bay floor to house the heavier modern equipment storage and safety, renovation of the  $2^{nd}$  floor living quarters and expansion of the window replacement and masonry repairs and code complaint improvements including new electrical, plumbing and heating/cooling systems for a climate controlled living environment.

The City has completed the design phase and is currently seeking construction bids. The project is expected to begin in June/July 2011 with completion in March 2012. The Fire Chief reports that vehicles and staff housed at the Mill Hill Station will be as assigned to the existing two fire houses in the City for the duration of the construction phase. This was deemed the best method of providing continued high quality fire service in the City, with modest adjustments to these fire stations.

The CIP Committee seeks your authorization to transfer/appropriate funds from an approved CIP FY'10 project where a fund balance remains following completion of the project, to a newly created CIP project. In this instance, the Fire Department completed the purchase of two new Fire Trucks (an Engine Vehicle and a Tower Vehicle) last year. The Department was successful in obtaining federal funds to pay for the cost of the Tower Vehicle that required a small match, and so funds remain to be programmed to the renovation of the Mill Hill Engine #3 Building.

The Vote to Appropriate to capital projects not named in the CIP requires two readings of the Council.

The Committee requests Council vote to discontinue the FY'Fire Department Apparatus Project and,

The Committee requests Council vote to appropriate the unexpended proceeds of the loan in the amount of \$882,770.81 to pay costs of Renovation and Addition of Chelsea Fire Department-Mill Hill Station Engine #3.

The request to transfer/appropriate the full remainder balance of \$882,770.81 will ensure that sufficient funds are available to undertake and complete the project, and pay for noneligible expenses under the grant such as Clerk of the Works, and most of the furniture, fixture and equipment. When these actual costs are better known in mid-year of FY'12. I expect to seek your approval for transfer of the remainder balance to other CIP projects.

I respectively request that the Council take action on these matters.

Re: Transfer from Police Department Salary Expenditure Line to Police Department Operating and Expense Line to cover mainly vehicle gasoline expense.

Ladies and Gentlemen of the Council:

The Police Department has requested a transfer of remainder funds in the amount of \$69,000 from the Regular Salary Expense line to the Operating and Expense line-Gasoline, in order to address a shortfall in funding for the gasoline expense.

The savings in the :Salary Expense" line is due to the three changes in personnel during the year, including the retirement of one officer, the resignation of one officer, and ,ilitary service leave of one officer.

The gasoline deficit funds are needed to cover actual expenses not anticipated due to the rise in rates.

In total, the Police Department expects that this transfer will meet all of the Police Department obligations for FY'11.

I have drafted a proposed order to make the transfer. I respectfully request that the Council take appropriate action on this matter.

Re: Debt Service Reserve Fund Vote to Dissolve

On October 4, 2010, City Council voted to appropriate excess funds in our Debt Service Reserve Fund for the purpose of paying off the City's 1998 General ObligationSchool Refunding Bonds and establishing our Annual Operating Stabilization Fund and our Capital School Building Stabilization Fund.

As this Debt Service Reserve Fund was established in 1994 for the sole purpose of servicing the School Construction Bond Debt, a Council Vote is needed to dissolve this Fund.

This action is recommended after consultation with the DOR, and our own City Law Department and Auditing Departments. Supporting documentation is available should you have require any specific information.

I have drafted a proposed order to dissolve the fund. I respectfully request that the Council take appropriate action on this matter.

Ordered, That in accordance with Chapter 44, Section 20 of the General Laws, the sum of \$882,770.81 representing the unexpended portion of the \$1,300,000 borrowed under the Fiscal Year 2010 Capital Improvement Plan for the purpose of Fire Department Apparatus-Acquisition of Fire Fighting Vehicles-Account 55301010, but which is no longer needed to complete that project, is hereby abandoned/discontinued and funds appropriated in the amount of \$882,770.81 to pay costs of Renovation and Addition of Chelsea Fire Department-Mill Hill Station Engine #3.

The following order was introduced by Councillor Vega-Torres. A motion from Councillor Vega-Torres to adopt under suspension was adopted.

ORDERED, that a Sub-Committee Meeting on Conference be held to discuss the role of the City Council Administrative Assistant.
