## NATIONAL ALCOHOL AND DRUG ADDICTION RECOVERY MONTH

Re: Salary Reserve Transfer to Fund USWA Sick Leave Redemption Benefit John Sleeper-former Refugee Services employee.

Ladies and Gentlemen of the Council:

The HHS Director and HR Director request additional salary support in the manner of \$8,500.00 to the HHS-(Refugee Services) Salary line to provide for a sick leave benefit due to a former employee, John Sleeper, in accord with the USWA (Steelworkers) collective bargaining agreement.

As you may recall, the Refugee Services Office in the Chelsea Health and Human Services Department was closed in the fall 2009 following the Commonwealth's withdrawal of grant funding, and its employees were laid off. Mr. Sleeper was a long term employee of the department.

The USWA collective bargaining agreement provides for a sick leave benefit for accrued but unused sick leave, however, eligibility for such a benefit is not realized until the employee or-in the case of laid off employees, the two-year term for recall expires.

Mr. Sleeper notified the City that he filed for retirement in June, 2011. Payment on the benefit is now due to him from the City.

I have drafted a proposed order to make the transfer. I respectively request that the Council take appropriate action on this matter.

## Re: Salary Reserve Transfer to Fund Temporary part Time Position

Ladies and Gentlemen of the Council:

The Library Director has requested additional salary support in the amount of \$2,520.00 to provide for a temporary staff person during the extended absence due to illness of a full-time staff person.

The Library Director reports that he has re-worked the staffing plan to address the absence and after adjustments of current staff to fill the gap, an additional temporary position (25 hours per week over 9-week period) is needed to adequately staff the building. If approved a former high school student employee who is currently enrolled at a local university has agreed to return to work for this period.

We believe this approach is the most cost effective approach to meeting the staffing gap and the general staffing needs of the library during the illness absence, and will significantly assist the Library in maintaining its excellent general customer service to the community.

I have drafted a proposed order to make the transfer. I respectively request that the Council take appropriate action on this matter.

Re: Proposed to Amend the Chelsea Zoning Ordinance-Airport Related Overlay District

Dear Council:

I am submitting for the Council's review and approval a zoning amendment to allow the rental of vehicles in the Airport Related Overlay District (AROD). As you may recall, the AROD District is located along a portion of Eastern Avenue and Marginal Street where

the ordinance allows for a range of airport related uses, by right and subject to a special permit.

For several years, the City allowed for a range of airport related automobiles uses in the AROD as it sought to promote re-use of the former oil storage lots. Later and in order to evaluate the impact of these newly established automobile uses, the City moved to restrict automobile-related uses in the AROD. With ten years now passed, I would venture to say that collectively the automobile uses have contributed significant to the City with little negative impact. It is sound and beneficial, therefore, that we provide our land use boards to again considering allowing the use in the AROD.

The proposed revisions necessary to allow this use are attached. The revisions are proposed only for the AROD and would allow "vehicles for hire and return vehicles for hire" subject to a Special Permit issued by the Zoning Board of Appeals. It would also eliminate "Storage of vehicles and return vehicles for hire" from the excluded uses from the definition of Airport Related Uses.

As in all proposed revisions to the City Zoning Ordinance, the Council must first consider it, and should the Council move to accept the request then it is moved to a public hearing by the Planning Board. I anticipate that if so moved, the Planning Board may hold a hearing in early October and provide a recommendation for action to the Council for final action at its mid-October meeting.

Thank you for your consideration of the proposal.
