Re: Statewide Public Safety Mutual Aid Law

Dear Ladies and Gentlemen:

The Commonwealth has enacted a new law that will provide a comprehensive mutual aid system for cities and towns to receive and share assistance during and after emergencies and disasters. The new law, M.G.L. c.40 & 41, expands what Chelsea has done over the past few years by entering into individual mutual aid agreements in regions, it extends the mutual aid to all cities and towns regardless of their proximities to each other.

There is also a mutual aid law for public safety incidents, M.G.L. c.40 & 4K that allows cities and towns to share resources as to non-emergency operations.

Each of these mutual aid laws requires the City to op-in in order to participate in mutual aid agreements. I recommend that the City Council vote to opt-in in order for Chelsea to enjoy the benefits of mutual aid agreements.
