The Town of Chilmark is seeking sealed bids for the demolition/salvage of existing electrical power system, supply and installation of electrical/water/communications lines, sub panel, power pedestals, and other necessary components on the Transient Yacht Dock and Fuel Dock. The site is located in the Town of Chilmark in Menemsha Basin.

MEETING

Attending a pre-bid meeting and site walk is strongly encouraged. This meeting will take place on Monday, October 22, 2012 @ 11:00 am at the Chilmark Town Hall. All bidders are encouraged to visit the site before submitting a bid. Submission of a bid constitutes an acknowledgment that the bidder has examined the site and is familiar with existing conditions.

RULE FOR AWARD

The contract will be awarded to the responsive and responsible bidder offering the lowest price for the services specified in this Invitation for Bids (IFB).

The Town will consider only responsive bids from responsible bidders for a contract award. A responsive bid is one which complies fully with all submission requirements stated in this IFB. Any bid which does not comply with all submission requirements may be rejected as non-responsive. A responsible bidder is one who demonstrably possesses the skill, ability, and integrity necessary to faithfully perform the work called for in this procurement and meets the requirements of Massachusetts law.

All bidders will:

1. Identify the proposed project manager and on-site supervisor, along with their qualifications to work on this project.
2. List the bidder's prior experience on projects similar to this.
3. State the financial ability of the firm to perform the work in this IFB.
4. Submit their bid on the attached Bid Pricing Sheet.
5. Bidders must submit a non-collusion form.
6. Bidders must submit a tax compliance certification.
7. Each bidder must submit with its bid a bid deposit equal to five percent of the amount of the bid. The bid deposit may be in the form of a certified, treasurer's, or cashier's check payable to the awarding authority from a responsible bank or trust company; cash; or a bid bond from a surety licensed by the Massachusetts Division of Insurance.

On M.G.L. c. 30, §39M projects, the town reviews the qualifications of the apparent low bidder after the bids are opened. The town may request any information from the bidder needed to determine if the bidder is responsible.

This is a Prevailing Wage project and the wage sheet is enclosed with this IFB.

The contractor must furnish a payment bond in the amount of at least 50 percent of the contract price. The contractor has 10 days from the date of notification of contract award to obtain the payment bond.

A bidder may correct, modify, or withdraw a sealed bid by written notice received in the office designated herein for bid submission prior to the time set for the opening of bids. After the opening, a bidder may not change any provision of the bid in a manner prejudicial to the interest of the Town, or to fair competition. The Town shall waive minor informalities or allow the bidder to correct them. If

a mistake and the intended offer are clearly evident on the face of the document, the Town shall correct the mistake to reflect the intended correct offer and so notify the bidder in writing, and the bidder may not withdraw the offer. The Town may permit a bidder to withdraw an offer if a mistake is clearly evident on the face of the document but the intended correct offer is not similarly evident.

The Town shall award a contract by written notice to the selected bidder by no later than November 28, 2012. This deadline may be extended an additional 30 days with the mutual consent of the Town and the Bidder.

All bid prices submitted in response to this IFB must remain firm for sixty (60) days following the bid opening.

The award of a contract will be conditioned on the selected bidder signing the Town's contract and providing the 50% payment bond within ten (10) days from the date of notification of award.

TIME IS OF THE ESSENCE and the demolition/salvage portion of the work is to be completed within 6 days from the date of notification of award under this IFB.

Notwithstanding any provision contained herein to the contrary, the Town reserves the right to cancel this procurement at any time before a contract is executed by the Town, in which event the Town will reject all bids received in response to this IFB. The Town reserves the right to reject any or all bids when it is in the public interest to do so.

REFERENCES: Bidders must submit a complete list of all current customers for which the bidder has installed utilities and previous customers for in the past three (3) years of projects of similar scope, with contact names and telephone numbers. A bid may be rejected on the basis of one or more references reporting poor past performance by the bidder. Bidders must have competed at least three (3) utility installations of similar scope for prior customers.

SEALED BIDS DUE: Sealed-Bids will be accepted until Friday October 26, 2012 @ 3:30 PM at the Selectmen's Office; Chilmark Town Hall; 401 Middle Road; P.O. Box 119; Chilmark, MA. 02535-0119. Bids must be marked on their face with "**Menemsha Phase 3 Utilities**". All bids will be opened at that time and read aloud. The bids must remain firm for sixty (60) days. **LATE BIDS WILL NOT BE ACCEPTED.**

PROJECT

This contract will work in coordination with two other contracts that demolish and remove the 1968 timber transient Yacht Dock and Fuel Dock, reconstruct a timber Fuel Dock and install a concrete/wood floating dock and timber transient Yacht Dock.

The utilities will serve the transient Yacht Dock by providing electrical power, potable water, and communications lines from the shoreside along the length of this dock. There will be two (2) salvaged/rehabilitated power stations reinstalled along the timber Yacht Dock and six (6) new utility pedestals (Eaton "Admiral" or better) and two new Eaton "Firehouse Marina" stations installed along the new floating transient Yacht Dock.

The Fuel Dock will be serviced by four electrical conduits, sized in consultation with Menemsha Texaco Service.

The utilities will serve the town owned docks in Menemsha with electricity, cable TV, telephone, and water. Contractor will supply and install all necessary material to complete this project along with all connections to the utilities on the land side and to all distribution points.

The Transient Yacht Dock serves approximately 16 boat slips of various sizes. Lines will be installed on supports under the 63 foot timber yacht dock and through 180 feet of 5 x 17" conduit/duct in the precast concrete floating dock. There will a sub panel on the landside. Coordination with the Yacht Dock contractor is essential and required. Electrical, cable TV, & telephone distribution to be via a control box on the Dutcher Dock bulkhead. Water lines will be mounted on but below the boat side whaler on the floating dock and along the railing of the timber yacht dock.

Contractor will rehab two (2) existing power stations with new receptacles, breakers and lighting before reinstalling them on the new timber Yacht Dock. The contractor will install four (4) water spigots, suitable for a public water supply, to supply yachts with potable water on timber Yacht Dock. Both power stations and water spigots will be spaced out to service the first four (4) slips.

The entire design and connection of the water system will be coordinated with the Menemsha Water Company and the Town.

Contractor is responsible for all excavation necessary and restoring the site conditions for the summer season. This shall include compaction, concrete, and asphalt paving as appropriate.

The Contractor will install five LED lights to illuminate the full length of the two ramps and platforms; that match the existing down lights on the West Dock Pier Connector.
