



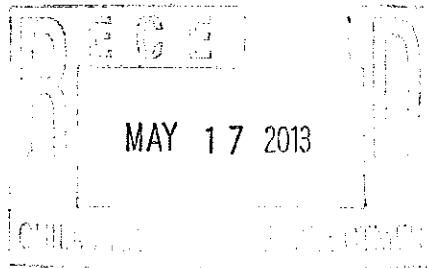
Dear Tim,


