Re: Coastal and Estuarine Land Conservation Program Request for Responses

Dear Municipal Official:

The Office of Coastal Zone Management (CZM) has issued a Request for Responses (RFR) seeking proposals for land acquisition projects consistent with the state's Coastal and Estuarine Land Conservation Plan, and that have significant ecological, conservation, recreation, historical, or aesthetic values. This RFR is in response to a notice of funding availability from the National Oceanic and Atmospheric Administration (NOAA) for their Coastal and Estuarine Land Conservation Program (CELCP). This is the seventh year CZM is using an RFR process to help identify the state's highest priority coastal land acquisition projects. CZM will review the applications submitted in response to the RFR to identify and select the state's priority coastal land acquisition projects and will then nominate them to NOAA for consideration in a national ranking process. NOAA will use the results of this national process to select projects for CELCP funding in FY 2014. The maximum amount that can be requested per project is \$1,000,000, and a 1:1 Non-federal Match is required.

The RFR is only open to public governmental entities (local, regional, and state). However, partnerships with non-governmental organizations are allowed and encouraged. Proposals are due to CZM by 1:00 PM on November 5, 2013. CZM will notify applicants of projects selected for nomination to NOAA shortly after the submittal deadline and those applicants will need to work closely with CZM to help develop the nomination package to NOAA. The deadline for CZM to nominate the state's priority projects to NOAA is November 15, 2013. For information on the CELCP, please visit the CZM website at www.mass.gov/czm/celcp.
