Dear BOS:

We have processed all the mooring permit, slip leases, and associated waiting list requests received to date. We began making the nanny calls on the 2nd of January and also sent e-mails to all the laggards. In some instances, and if we had not been able to make voice contact Ginny sent several e-mails and left several messages. As in the past many people who do not wish to renew simply don't reply even though they are asked, in the instructions, to send us a letter relinquishing their permits and/or slips (or waiting list places). This makes for a lot of additional work and some confusion about people's intentions. This year we actually have had a large number of moorings relinquished and there are also several (of recently deceased permit holders) which we're trying to confirm.

On the West Dock, Alex Preston has relinquished his slip. The next name on that chronological waiting list is Daniel Campbell. On the floating Dock, Marc Villa has relinquished his slip which brings the number of slips leased to 17. For some time we've leased out a small one at the S end as # 18. Until the Coast Guard boat house is finished we will not be able to determine whether the number remains at 17. The next person on that chronological list is Bradley Carroll, and following her is Jill Alman Bernstein. Please refer to the Harborways Rules and Regulations for further information because there are some questions about their eligibility.
