**Cape Light Compact (Compact) Member Towns and Counties** 

**Dear Compact Member Towns and Counties:** 

I am writing this letter to clarify recent misrepresentations of fact being circulated regarding Cape Light Compact financial records and their transparency to county and state agencies including the Barnstable County Assembly of Delegates.

There are no outstanding records requests to Cape Light Compact from the Assembly of Delegates. The Assembly made one request, and one request only, for financial records to the Compact. This written request from the Assembly's subcommittee was dated November 21, 2011 and asked for copies of "all audited financial statements and annual budgets for FY 2005, 2006, 2007, 2008, 2009 and 2010." (The document request is attached.) The Compact responded with the requested documents on December 15, 2011. The Assembly did not request any additional financial records from the Compact, and as confirmed by the Clerk of the Assembly, there have been no additional requests for information or clarification.

Fourteen months after the request to the Compact, on January 18, 2013, the Assembly wrote Barnstable County Treasurer/Finance Director Mark Zielinski for a list of 9 specific Compact financial reports. The County responded with the requested reports on January 31, 2013. (Those two document requests and responses are enclosed with this letter.)

Comprehensive information regarding the Compact's finances, including budgets and audit reports, is publicly available on the Compact's website. (Please see the enclosed website guide to location of Cape Light Compact financial information.)

In addition to the information already available to the public, I have asked Compact staff to work with the County's Finance Department to collect and compile any additional 1997-2013 data regarding the Compact's expenditures and revenues that was <u>not</u> requested from Mr. Zielinski and the County by the Assembly of Delegates. Most of this information is already contained in the reports the County provided to the Assembly, and the budgets and audit reports that have been publicly available for quite some time; but the Compact understands that some parties are interested in the seeing all Compact expenditures and revenues in their original format.

I estimate that this information will be available for public viewing on the Compact's web site no later than March 17, 2014. It is my hope that providing public access to 16 years of Compact expenditures and revenues will finally allay any concerns Cape and Vineyard residents might have that Compact funds have been spent inappropriately or illegally.

<u>I cannot state strongly enough that the Compact has nothing to hide</u>. The Compact's financial activity has been included as an agency fund in the Barnstable County audit since the Compact began in 1997. At its September 12, 2012 meeting, the Compact Governing Board voted to fund additional measures on the interest of public transparency. Agreed Upon Procedures (AUP) for the years 2003-2008 were commissioned and published. For 2009 going forward, annual independently audited financial statements, specific to the Compact's operations and prepared by an outside firm were performed and published. The audits for 2012 and 2013 are in fact about to begin.

The coming years will bring challenging energy issues, such as how to cope with increasingly volatile natural gas markets and how to ensure that grid modernization benefits residents and businesses on the Cape and Vineyard. These are the kinds of issues that the Compact is ideally suited to take on--but our success depends on our ability to have frank discussions with our constituents, conversations not tainted by unfounded distrust and false allegations.

We hope that our efforts at greater transparency will allow others to accept what Compact staff and Board members already know to be true —we have nothing to hide, and we want to get back to working on the region's critical energy issues, with our members as our partners.

Lastly, it is my sincere hope that the many recent actions taken by the Compact to improve transparency will enable Compact member towns/counties to affirm that their appointed representative is acting in good faith and is indeed upholding his/her responsibilities as a Board member.

Pursuant to Assembly of Delegates adopted Resolution 11-02 and by the authority granted through the Cape Cod Regional Government Home Rule Charter Section 2-7 and 2-8 (b) ii, the Special Committee on Inquiry into CLC and CVEC, by this letter, requests that the documents described herein be supplied and/or made available by Cape Light Compact for the Committee's review.

Please produce copies of the following documents and materials:

- 1) Any and all grant applications, award letters, grant agreements and correspondence relating to the grant of \$520,000 from ConEd Solutions to Cape Light Compact in 2006, including any such documents dated prior to 2006.
- 2) All audited financial statements and annual budgets for FY 2005, 2006, 2007, 2008, 2009 and 2010.
- 3) All annual reports to each member municipality dated or distributed at any time subsequent to January 1, 2005.
- 4) Meeting minutes from FY 2006, 2007, 2008, 2009, 2010 and 2011 (excluding executive session minutes not yet released). Note: this request may be satisfied by providing these documents for review by members of the Special Committee.
- 5) Any letters, memoranda or other correspondence from or to any elected official or public board member of the Town of Brewster concerning the Brewster Wind Project and/or the decision to seek DPU review of the denial of that project.

- 6) Any correspondence from the State Ethics Commission or others related to membership of staff or directors on multiple boards.
- 7) All statements of policy and/or description of procedures that are in place at CLC to identify and deal with any potential conflict of interest issues that may arise, including without limitation all documents regarding shared legal representation prepared as required Bylaw #1.

At its meeting on November 16, 2011, the Special Committee agreed to request that the above listed documents be supplied to Assembly Clerk Janice O'Connell, as soon as possible, but no later than December 15, 2011. Receipt of these documents by December 15, 2011 will provide the committee with time to review the information provided prior to their next meeting, which has been tentatively scheduled for January 4, 2012.

If you anticipate any difficulties with this request, please let the Special Committee know as soon as possible. We thank you in advance for your cooperation.

The CLC Chart of Accounts for CLC exists and is attached labeled "CLC Chart of Accounts"; however, a Chart of Accounts in "Format I and Format II" does not exist.

#### Chart of Accounts - Format II.

No such document exists.

It is not clear which account you are requesting information about. Please specify, as you have done in your request below, what documents you are requesting, and for which account.

In order to comply with your request, the Detailed Trial Balance Report was printed and competitively sensitive and customer information (names, addresses, rebate amounts) was redacted prior to sending you the report.

The Summary Trial Balance Report of the CLC Energy Efficiency Fund is attached labeled "Summary Trial Balance Report of the CLC Energy Efficiency Fund."

I would also like to request copies of the Balance Sheet report for each of the funds noted in my earlier request report for each fiscal year (including the YTD FY2013).

I would like to note that compiling, reviewing and preparing the attached financial statements required over twenty-six hours of staff time. Printing costs and average labor costs exceed \$1,500.
