Good Afternoon Tim,	
Over the last few months the Corps has been working on design documents for repair of the east and west jetty of Menemsha. We are just about complete with this process and would like to collaborate with the Town on points of access to the east jetty. Specifically we will need things like storage / laydown areas, office trailer spots, etc. Given its width I'd expect a single medium size excavator and small loader working from the crest of the east jetty, or a large barge mounted excavator placing new or manipulating existing armor stone from the water. Depending on which scenario the contractor elects to use the armor stone may be barged upto a vessel mounted excavator, or driven in and dumped near the east end of the jetty for the land based equipment to get.	
Trying to account for both scenarios I have put together a graphic to begin discussing what areas are owned by whom so we can start a Right of Entry process. We are expecting to do the work during the winter (prior to April 1) of this year (2014-2015) so that we can have the smallest footprint/impact on the Town as possible. Please review the graphic and give me any feedback / concerns you may have so that we can tweak dimensions before an official Right of Entry is sent to the town.
