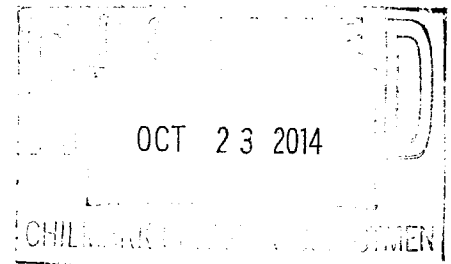

REPORT YOUR HARVEST ONLINE: Go to www.mass.gov/massfishhunt, login to your account and click the "Report A Harvest" button. You must check in your deer within 48 hours after harvest.

NOTE: All deer harvested during shotgun deer season MUST be brought to a physical check station. Online reporting will NOT be available during the shotgun deer season.
