

## Boating Rules and Regulations

- · No overnight anchorage.
- No discharge of waste of any kind. Contact the Chilmark Harbormaster for use of the pump-out facilities.
- Maximum speed limit is 4 knots. No wake is permitted.
- Maintain a 150ft distance from red and green channel markers.
- Yellow markers delineate aquaculture areas.
- Safety First! Please be courteous and conscious of those sharing the waterways with you. Swimmers, non-motorized boats and wildlife may be present. Be aware.
- Wind surfing is not allowed in Menemsha Basin, Menemsha Creek, the channel or within 300 feet of the beach.
- No swimming or diving in the harbor or channel from Memorial Day to Labor Day.
- Do not tie vessel to any navigation aids.
- No anchorage in the harbor or navigational channels.
- Mooring by permit only. See the Harbormasters.
- Life Jackets: Each paddler must have a USCGapproved Type I, II, III, or V life jacket. A child 12years old or younger <u>must</u> wear their USCGapproved, appropriately-sized life jacket while on board any vessel.
- If you're on the water after sunset, you need to have a lighting device to warn other boaters.
- The USCG define SUP boards operated outside a surfing, swimming or bathing area as "vessels" and therefore need to adhere to those rules. It is not advised to use these in Menemsha Channel, as they create a navigational hazard.

## Navigation

Boaters be aware that the current runs swiftly through the inlet. The inner harbor is just inside the inlet and both are well-marked. The inlet continues into Menemsha Pond. Also be aware that there are very shallow sections and navigate accordingly. Recent dredging activities have altered the channel bottom significantly. Follow the channel markers and watch the tides.

# Eco-Friendly Boating

The impact of recreational boating on aquatic ecosystems is significant. Even small quantities of toxic products in the water can disrupt this balance, with lasting harmful effects.

How can you help?

- Read the label and choose phosphate- and chlorine-free products that are non-toxic and environmentally safe, such as vinegar and baking soda.
- Avoid conducting boat maintenance on the docks or over the water.
- Use more elbow grease and fewer cleaning products, scrub and rinse with fresh-water.
- Properly dispose of unused boat maintenance products.
