

Dear Timothy:

Thank you for your support and continued membership in the MIIA Property and Casualty Group, Inc. To ensure your continuous insurance protection, we have enclosed MIIA's renewal contract binder and invoice for FY2018. Specifically, you will find the following:

- Interim Coverage Binder, detailing your coverage with MIIA;
- New and improved one invoice for Property, Liability, and Workers' Compensation.
- Statements (yellow and green sheets, 2 copies of each) that show your account balances as of June 30th;
- Your MIIA Rewards credit, if you participated in this program, shown on the new invoice; and,
- Flex Grant Program Application should you choose to consider this option.

Further, please note that in January the MIIA board declared **\$2,500,000 in additional Participation Credits** payable to qualifying members. If you qualify for these additional credits, the credit is reflected on the invoice enclosed. You may use this credit as a deduction from your FY2018 premium payment, apply it to other outstanding MIIA balances due, or request a check. If you have other credits with MIIA, they will be shown in your statement enclosed, and you may deduct this amount from the renewal invoice as well.

You should also be aware that you are eligible for a <u>3% discount</u> if you pay the entire premium by July 31st. This early payment discount applies to FY2018 premiums only. Early payment discounts help to lower premium costs for MIIA members.

If you have earned MIIA Rewards credits, the credit is shown on the Invoice. You may request a check for this amount, use it as a premium credit or use up to 50% of it for a Flex Grant. (Please reference attached application.)

As a MIIA member, you receive broad protection from a financially stable provider that serves only Massachusetts municipalities and related public entities. # MIIA Rewards Flex Grant Program Application Fiscal Year 2018

The MIIA Flex Grant provides an additional option for use of earned MIIA Rewards credits. Currently Rewards credits are designed to reduce premiums in the following fiscal year.

The MIIA Flex Grant gives members the additional option of having a portion of the MIIA Rewards credit, not to exceed 50%, applied to a Rewards Flex Grant. Rewards credits under this option are released to the member in the form of a payment to be used for risk management purposes, subject to MIIA's approval.

# Eligible items to be considered under the MIIA Flex Grant in addition to those currently eligible under the MIIA Risk Management Grant Program include but are not limited to:

- o Personal Protective Equipment: hard hats, clothing, safety goggles, turnout gear, bulletproof vests, raingear etc.
- Equipment: chainsaws, ladders, generators, automatic external defibrillators, two-way radios, infrared scanners, GPS, tablets, street signs, garage door openers, etc.
- Repairs: roofs, gutters, walkways, stairs, lighting, etc.
- Services: tree pruning/removal, catch basin cleaning, sewer video/cleaning, parking lot paving, sidewalk repairs
- o Remediation/removal: asbestos, lead, mold, underground tanks, floor drains, hazardous waste
- o Playground/skatepark maintenance and repairs, replacement of safety surfacing
- o Ergonomic equipment: desks, chairs, monitor stands, keyboard trays, etc.
