## IMPORTANT INFORMATION ABOUT YOUR ACCOUNT

Dear Comcast Business Customer:

We wanted to let you know about some upcoming changes that will impact your Comcast Business account starting on September 21, 2017.

The TV Adapter for the first TV on your account will now be billed separately from your video service at \$0.50 per month. As a loyal business customer, we will apply a twelve (12) month discount of \$0.50 to your account starting with your next bill to assist you with this change. The price of your TV Basic video service will not change and will continue to be billed at \$4.95 per month, or \$24.95 per month if you are a single product video service customer.

In addition, the current HD equipment charge will no longer be charged on a per TV basis. Instead, we will charge for HD service once per account for all TVs and the charge will appear as an HD Technology Fee. The price will change from \$5.00 per TV to a single monthly price of \$9.95 for HD service to <u>all</u> TVs. If you have multiple TVs with HD-capable equipment this change may result in a monthly savings to you.

To assist you in identifying how these changes impact your overall bill, please refer to the sample guide provided on the reverse side. We hope you find these changes assist in simplifying your bill.
