- 8500 kWh was saved through implementation of these energy efficiency measures.

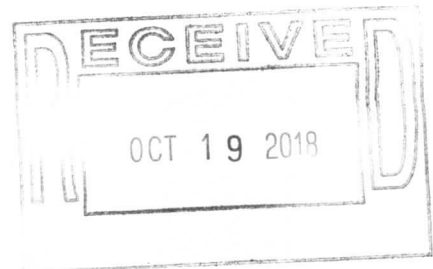
