


PETITION FOR 2019 CHILMARK ANNUAL TOWN MEETING




We the undersigned residents and registered voters of the town of CHILMARK submit this petition and request that the following language be placed as an article on the warrant for vote at the 2019 Annual Town Meeting for the town of CHILMARK.

Article __ Dedication of Funds to Martha's Vineyard Housing Bank.

To see if the Town, which has already imposed a local excise tax upon the transfer of occupancy of a room in a short-term rental based on Mass. Gen. L. ch. 64G, Section 3A (as set forth in 2018 Mass Acts c. 337, s. 6), will dedicate in perpetuity three percent (3%) of the total amount of rent for each such occupancy to the Martha's Vineyard Housing Bank for the creation of housing on the Island. Funds collected under this section prior to the enactment of legislation creating the Housing Bank and fulfilment of all conditions precedent to its creation shall be held in a restricted account to be transferred to the Housing Bank when it is fully enacted and able to proceed.
