My name is Charles Palmieri and I am the Secretary of the Cape and Islands Chapter of the IAEI located in South Eastern Massachusetts.

We are in the process of finalizing plans for our tri- annual preview of the incoming 2020 National Electrical Code. Our chapter has led the South Eastern Massachusetts area in being the first local chapter of the International Association of Electrical Inspectors to preview the incoming NEC for the last 10 (30 years) code cycles. Our attendees include installers, contactors, engineers, and other industry partners from across the New England States. We always schedule our conference which we have called "Super Code" during the month of April preceding adoption of the incoming code. This year our conference dates are Friday April 12th, and Saturday the 13th of 2019.

I send you this correspondence as an invitation to participate in our Trade Show. Each year we hold this event we have been fortunate to have 20 plus manufactures, manufacture representatives, and supply houses support the Cape and Islands Chapter of the International Association of Electrical Inspectors, I am sure you are aware that our organization is dedicated to the development of Code and Industry Training to insure safe electrical installation.
