- > As it's getting closer to Town Meeting, we want to be sure that your Committee has all of the key elements in the Dune Ridge solution. To date, we've provided the engineering data for the dune ridge and road. The last major element is the parking.
- >
- > Here are the main points for the presentation on parking (schematic is attached):
- > The two 1/2 acre lots would be leased to the Town for parking We have
- > been communicating with Peter Weldon. If the Town wants to pursue this proposal further, it will need to contact Peter Weldon or his agent directly. Peter has indicated his interest in working with the Town on a parking solution. But, the first step is for the Town to decide whether it would like to proceed.
- > The maximum capacity of the proposed parking area is 40 vehicles (same capacity as current parking lot).
- > The Town will be required to maintain a vegetative planted border around the parking area to screen from the neighbors.
- > Parking on these lots is proposed as a component of an overall solution. This cannot be unbundled from the rest of the dune ridge solution.
- > We will have a proper engineering map for Tuesday.

- > The meeting with H & A went well on Monday. We prepared a set of minutes and forwarded them to H & A for their review. Once we have agreed on the minutes, we'll send you a copy.
