I have included a photo with the bridges drawn in if we could pick the best of all possible sites. I did not bring the bridge to Great Island because if there were a natural disaster bad enough to make the barrier beach un-passable it would also likely take out the long and low causeway that connects Great Island with the barrier beach and then the rest of the point. Of course, the solution I have included would be the very best solution but it is also the furthest out of reach. The cost is the most obvious drawback but the politics of coming ashore in Blacksmith Valley and finding a ROW out to the state road that everyone could agree to, well, that seems a bit difficult too.
