The Homeowners are now and have always been agnostic about parking. The Selectman plan for the beach presented us with a parking location which was not subject to our input, in largest part because the land would be available and under town control as part of the larger proposal. Our members hold different personal views on the best plan for parking. Our Association is focused entirely on safe long term access. Beach parking has always been subsidiary and we have assumed that your Committee (like Selectmen earlier) would recommend a parking solution that you think works best for the Town, and that we would do what we reasonably can to help the Town implement that solution. We have no official position on where parking is located as an independent issue.

I hope this is helpful in correcting another misstatement from FOS."
