- 1. Liz to contact towns of Guilford, Thompson and Sterling about their procedures for handling farmers' or citizens' concerns and complaints [120521 6c(2)].
- 2. Change in 490A acreage requirements [120521 6c(3)].
- 3. For zoning and tax purposes, broaden right to farm policy to allow farms by right to engage in business activities that are not traditional farming but are related to or consistent with farming [120416 6c].
- 4. Investigate the tax rates for the 490 program with the goal of adhering to the current CT Dept of Agriculture guidelines for valuations of all farmland in town [121119 6e].
- 5. Authorize additional tax exemptions that the state allows for farm machinery (beyond the original \$100,000 exemptions), farm buildings and extra property tax abatements on certain types of farms [120416 6c].
- 6, Involve the Colchester school system in farm awareness programs as a means of stemming future problems as well as educate local students about the role of Colchester's farms in food production and their community [121119 7].
