- 4. That (i) the Bank is further authorized to honor each check, draft or other order of payment of money (and "Item") drawn in the name of this Organization, including Items payable to the order of any person authorized to sign on behalf of this Organization, when bearing or purporting to bear any of the facsimile or printed signatures appearing on a Bank signature card for this Organization, regardless of by whom or by what means the actual or purported signature may have been affixed thereto or printed thereon; (ii) all previous authorizations for the signing and honoring of items are hereby ratified and continued in full force effect as amplified hereby, and (iii) this Organization agrees to indemnify and hold the Bank harmless from and against any and all claims, suits, judgments, losses, costs and expenses (including reasonable attorneys' fees) that the Bank may incur as a result of the use of such facsimile or printed signatures on Items.
