Members discussed things they liked about other firms but were in agreement that Tecton was their top choice. Bids for each firm were distributed. (see summary attached) Tecton was not the lowest bidder but their was consensus among members that Tecton was still the best choice and could moved

forward with the project quicker than other firms due to already being knowledgeable of the project and the town itself. A. Tarnowski motioned to enter into agreement with Tection as the architect firm and move forward with detailed design based on their submitted RFP in the amount of \$2,047,000, seconded by S. Wells. Vote was unanimous. **MOTION CARRIED.**
