- 1. Call to Order: Chairman Tyler called the meeting to order at 7:07 p.m..

- 4. Discussion and possible action on selection of construction management firm: S. Wells said due to having missed the first interview with Gilbane on December 8th he would contribute to the discussion but would not be giving a rating of each firm and would abstain from voting on the selection.
 Members were then given the opportunity to rank each of the three firms,

none of which clearly ranked highest. Members discussed things they liked and any concerns that they had about each firm Bids for each were distributed. (see summary attached) After much discussion the consensus among members that while they are not required to chose the lowest bidder, based on the fact that it was felt by members that all the firms could do an adequate job, going with the lowest bidder would be in the best interest of the project. A. Tarnowksi motioned to select O and G as the Construction Manager for the WJJMS Building Project and forward the recommendation to the Board of Selectmen to enter into contract with O and G in the amount of \$2,586,350, seconded by I. Malsbenden. Vote was unanimous with S. Wells abstaining. **MOTION CARRIED.**
