

Approval of Construction Documents and Construction Cost Estimate

BACKGROUND

On August 18, 2016, the members of the Colchester Board of Education, William J. Johnston Building Committee and others attended a workshop presentation on the construction documents for the William J. Johnston Middle School and Pupil Services projects. Since that time, the design team has incorporated the comments received and prepared the documents for state approval and bidding.

The Architect, Project Manager and Construction Manager have reconciled the construction cost estimate and the projects are within budget. At this time, the documents and estimate require the approval of the Building Committee in order to maintain the project schedule.
