


Board of Selectmen Regular Meeting Minutes Tuesday, January 6, 2009 Colchester Town Hall Meeting Room 1 – 7:00 p.m.

1. Call to Order: First Selectman L. Hodge called the meeting to order at 7:03 p.m.

- 2. Additions to the Agenda: J. Malsbenden moved to edit item #5b and 5c by editing the text to read "member/alternate", add a new item #11 "Discussion and Possible Action on Authorizing Contract with Swiss Cleaners to Provide Uniforms to Local 506 Bargaining Unit Employees" a new item #12 "Discussion and Possible Action on Awarding 2009 Concession Stand at Parks & Recreation Complex", a new item #13 "Discussion and Possible Action on 1st Annual Dunk n' Donate Basketball Jamboree Sponsorship Opportunity", a new item #14 "Discussion and Possible Action on Sponsorship Opportunity for 2009 Colchester Lunch Time Music Series", and to renumber the remaining items accordingly starting with item #15, seconded by G.
