

Dear Board of Select men,

Since April 2009, the Commission on Aging has been reviewing various alternatives for a project that its members might desire to pursue toward the end of improving conditions for the seniors of the Town of Colchester.

At it June 2010 meeting, the Commission heard a shorter version of the presentation of the Long Term Care Plan which was presented to the State Legislature by the Connecticut Commission on Aging and the Long-Term Care Advisory Council. The Long Term Care Plan's goal is to help people with long term disabilities, such as aging, to stay in their homes or help them live more cost effectively in the community as opposed to living in a nursing home before that level of care is needed, with Title 19 (and all Connecticut taxpayers) paying the bill. This Commission has also scheduled a presentation by ASCA from Noank to have them give a presentation to this Commission at our Senior Center, which will be open to our community, on resources which are available to family and care givers to help keep their loved ones in the community. That presentation is tentatively scheduled for Wednesday October 20 at 7 pm.

The Commission has also started the process of reviewing its by-laws toward the end of making some revisions in areas where its current practices are not reflected in its by-laws.

# **Commission Chairman's Notes Colchester Sewer and Water Commission**

- Stream Flow Standards and Regulations DEP is still reviewing the results of the public hearing. However, based on some recent discussions, the Connecticut Water Works Association (CWWA) drafted a letter to Governor Rell with copies to the chairs and members of the legislature's Regulations Review Committee outlining continued concerns with the proposed stream flow regulations. The letter indicated CWWA recently met with DEP to discuss the proposed regulations but received no assurances that the regulations will be substantially revised to address concerns regarding the impact of the regulations on the availability and cost of public water supplies in the state. After discussion with Chairman LeMay, he agreed to support the letter as it basically was the same support provided earlier in the regulatory process.
- STEAP Grant Sewer and Water Infrastructure Expansion an official kick-off meeting is scheduled for Monday the 19<sup>th</sup> although information has already been exchanged and Weston & Sampson is working on the mapping component at this time.
- Conservation Measures Due to the recent spell of very hot weather with limited rainfall, the DPH Drinking Water Division issued a communication to all water companies in CT encouraging them to keep a close eye on their trigger levels for conservation measures. The Department has reduced the pumping rate in one of its wells and has activated the second well to provide a more balanced withdrawal from each well. This has resulted in sustained drawdown water levels and adequate pumping capacity to meet the demands of the system. Levels are being carefully monitored but there are no reasons at this time to institute either voluntary or mandatory conservation measures.
