Discussion: Steven Shuster asked the question as to how much the savings were collectively in the line items; Insurance, Heating oil, Transportation fuel, Electricity, Payroll and Salary from the 2015/2016 Board of Education budget and the 2016/2017 proposed Board of Education budget. Maggie Cosgrove answered that the savings discussed throughout the budget meetings pertained to Insurance, Heating oil, Diesel fuel, Electricity and Gasoline. Those savings total \$1,062,970.

Moderator called for a voice vote on Item #2, SO VOTED AND CARRIED.

Motion to move Item #3, to adjourn to Referendum vote on Tuesday May 5, 2015 between the hours of 6:00 a.m. and 8:00 p.m. at Colchester Town Hall, made by Don Kennedy, seconded by Dorothy Mrowka. SO VOTED AND CARRIED.
