### RESOLUTIONS

WHEREAS, the Board of Selectmen of the Town of Colchester adopted a resolution at its duly called and held regular meeting on April 7, 2016 approving the terms of the Purchase Agreement by and between the Town and The Trustees and Proprietors of Bacon Academy recommending that the Town purchase the real property known as 95 Norwich Avenue, Colchester, Connecticut for a purchase price of \$275,000.00 and recommending the Town appropriate \$283,240.00 for the costs related to the Transaction from the Unassigned Fund Balance of the Town's General Fund, consisting of \$275,000.00 for the purchase price of the Property and an amount not to exceed \$8,240.00 for closing costs and legal fees related to the Transaction;

WHEREAS, the Board of Finance adopted a resolution at its duly called and held regular meeting on April 20, 2016 recommending that the Town purchase the Property in accordance with the terms of the Agreement and approving, subject to the further approval of the Town Meeting, the Supplemental Appropriation; and

WHEREAS, the Town has entered into the Agreement for the Property and in order to complete the Transaction, the Town shall enter into such other documents deemed necessary, desirable, advisory or appropriate by the First Selectman in connection with the Agreement.

## BE IT RESOLVED:

**SECTION 1.** That the Town purchase the Property in accordance with the terms of the Agreement.

**SECTION 2.** That the Town appropriate \$283,240.00 for the costs related to the Transaction and finance such appropriation by using \$283,240.00 of the moneys available in the Unassigned Fund Balance of the Town's General Fund, consisting of: \$275,000.00 for the purchase price of the Property and an amount not to exceed \$8,240.00 for closing costs and legal fees, including title review, title insurance and all other costs related to the Transaction.

SECTION 3. That the First Selectman's execution of the Agreement is hereby ratified and the First Selectman or his designee is authorized to act for the Town under the Agreement, that the Board of Selectmen, Board of Finance and other Town officials or employees are authorized to take all other actions necessary and proper to consummate the Transaction and that all previous action taken by the Town, its officials or employees in connection with the Transaction are hereby ratified.
