- **4. In this case, it was for a two year term and for a four year term. He suggested that the commission might look at adding a provision to the charter that would prevent this from happening in Colchester. The commission appreciated Mr. Schuster's suggestion.
- 5. Updates. Chairman LePage reported.
 - a. He received a letter from Jim Pagglioli recommending a change in the number of members on the Sewer and Water Commission to five and two alternates. Charter Section C-902b.
 - b. Chairman LePage met with the town attorney and she will provide a written position on the position of town Treasurer.
 - c. Chairman LePage met with First Selectman Shilosky regarding the submission from the Police Commission.

6. Options for Informing Public of Commission's Work.

The commission discussed at length the matter of how the public will be informed of proposed changes in the charter. Members suggested a variety of options. It was agreed that at the next meeting, the commission will discuss which sections are ready for publication.

In regard to the existing Town of Colchester Charter Section C-902.B, the Sewer and Water Commission is to consist of a nine member board. Over the course of the past years, there has not been enough public interest in serving on the Sewer and Water Commission in order to fill the seats. This has resulted in a technical shortage of quorum to occur at meetings.

It has been requested by the Sewer and Water Commission in order to obtain sufficient quorum at the meetings, to reduce the membership of the Sewer and Water Commission to 5 members with 2 alternate members also being appointed when appropriate interest occurs. This number would effectively manage the day to day oversight as directed in the Town of Colchester Charter.
