6.1.2 First Selectman's Update.

First Selectman Hodge asked Chief Cox to explain his request to purchase a powered ambulance cot. With a trade-in of a manual lift cot, the cost would be \$10,693.21 including battery, a back up battery with charger, a three-year service warranty and accessory equipment. The purchase of the cot would reduce the possibility of a lifting injury to personnel. There have been frequent transport calls requiring additional manpower to assist the ambulance crew responding to the call. The powered cot would also eliminate some of this additional need.

to approve the transfer of funds from the equipment reserve account to purchase

one powered ambulance cot as requested.

L. Hodge will prepare a list of items during the budget process to be discussed for possible bonding.

A \$50,000 grant has been given to the Town to develop regulations for 'workforce' housing, similar to affordable housing. The monies will be used to study, review and develop the Town's Zoning Regulations.

The Post Office has instituted a new policy to charge for returned mail that is undeliverable due to incorrect address or unable to forward. This could have an impact on the budget and L. Hodge is trying to work with the postmaster.

Legal fees and the health insurance are also concerns at this time.
