ELDERLY TAX RELIEF ORDINANCE DISCUSSION.

Selectman Coyle reviewed the recently revised <u>Tax Relief Program for Homeowners who are Elderly or Permanently and Totally Disabled proposed ordinance.</u>

This ordinance was originally adopted in 1993 and recently revised and approved by the Elderly Tax Relief Task Force to be presented for approval to the Board of Finance. The impact to the budget will be the difference in the 3% proposed interest rate for the time of deferment and the 18% on delinquent taxes.
