

a. Discussion and Possible Action on Amendments to Fund Balance Balance Policy

- R. Tarlov made a motion to add to the Fund Balance Policy that the Board of Finance has the authority to establish the circumstances regarding committing fund balance, and has established a minimum fund balance level of 5% of total annual operating expenditures (including debt service) that represents Committed Fund balance under the definitions set forth in GASB #54, Seconded by J. Ringo. All other members present voted in favor. MOTION CARRIED.
- M. Caplet made a motion to add to the Fund Balance Policy that the Board of Finance delegates authority to assign fund balance as defined in GASB #54 to the Chief Financial Officer, Seconded by R. Esteve. All other members present voted in favor. MOTION CARRIED.

The above listed changes to the Fund Balance Policy approved by the Board of Finance on 5/19/10 are to incorporate requirements under Governmental Accounting Standards Board Statement # 54 "Fund Balance Reporting and Governmental Fund Type.

The CFO will draft the changes to the fund balance policy, including updating references to fund balance categories as defined in GASB #54 and present the full revision to the Board od Finance for final review and adoption.
