Esteve MOTIONED to approve a transfer of \$56,602 from "Use of G/F Assigned Fund Balance (18501-36250)" to "BOE Capital Reserve (18501-50800)" for security improvements at the school facilities. SECONDED by A. Shilosky. All others approved. MOTION CARRIED.
