6. Bacon Academy Board of Trustees

Arthur Liverant stated that the board of trustees is in a difficult financial position and are asking the town and Board of Finance for assistance. The Board of Trustees have been hit by the recession and rising costs of overhead and their mission is to take care of the old Bacon Academy, Day Hall and Nathaniel Foot House. The Board of Trustees is hoping to create an arrangement with the town to possibly purchase the Senior Center from the Trustees.

10. LIAISON REPORTS
